

Auditor Says: "City In Strong Financial Condition"

January Council Meetings

At its January 8 meeting the council heard a presentation on the city audit report for the fiscal year that ended June 30, 2019. Ingrid Sheipline, managing partner for the auditing firm of Richardson and Co., said that the city had "adequate reserves" and was in "strong financial condition."

Sheipline also pointed out that instead of the projected deficit, the city had ended the previous fiscal year with a surplus in the General Fund. She said the city's only debt was the \$7.9 million still owed the state revolving fund on the original \$12 million loan to build the waste water treatment plant.

She finished her presentation saying; "We found no compliance issues with state regulations, and no discrepancies needing adjustment." She called that "rare" and applauded the city's financial director, Laurie Van Groningen, for producing such a clean audit.

Later in the meeting the council unanimously approved a resolution authorizing the city manager to enter into an agreement, not to exceed \$25,000, with

City Hazardous Vegetation Ordinance Workshop

One of the primary lessons to be learned from the wildfire that destroyed Paradise, California is that allowing hazardous vegetation to go unabated can be a fatal mistake.

The entire city council, along with the city manager and city attorney, hosted a public workshop on January 15 to review a

After initial abatement is performed, property owners will be required to regularly maintain their defensible space in accordance with requirements set forth in the ordinance.

The proposed ordinance will add Chapter 8.32 to the Municipal Code and addresses the responsibilities of landowners, neighbors and vacant lots.

as primary ingress and egress routes – as a public nuisance that must be abated by the property owners to create defensible space around those structures and roadways.

The ordinance does not require or expect removal of entire trees, but will also require:

- All trees, hazardous vegetation and ladder fuels within defensible space areas to be pruned and removed to a minimum height of 15 feet above the ground.
- Removal of tree limbs extending to within 10 feet of a chimney or stovepipe.
- Removal of all climbing vines from trees and structures.
- Maintenance of all vegetation adjacent to or overhanging a structure free of dead or dying wood within a 10-foot distance from the structure.
- Keeping roofs and rain gutters free of leaves, pine needles and other hazardous material.

Unimproved parcels will have to meet the same requirements, as well as cutting and removing all weeds and grasses down to a height of six inches.

When a house is less than 100 feet from a neighboring property line, and hazardous vegetation on the neighboring property presents a fire hazard, the owner of the neighboring property will be responsible for

proposed amendment to Colfax Municipal Code Title 8 to require hazardous vegetation abatement and establishment of defensible space that will apply to all parcels throughout the city.

Defensible space is defined as that area which is adjacent to each side of a building or structure and must be cleared of all combustible material, hazardous vegetation, brush, flammable vegetation, or combustible growth.

"The major issue," said CalFire Battalion Chief Brian Eagan, "is getting neighbors to clean up their property."

Specifically, the ordinance will declare hazardous vegetation and combustible materials

– within 100 feet of a structure, or within 10 feet immediately adjacent to roadways serving

creating the required additional defensible space.

In all cases if a property owner fails to abate hazardous vegetation, or to maintain structure and roadway clearance requirements, the City may abate the nuisance – without further notice – at the property owner's expense.

Enforcement will not begin until January 2021. The ordinance will receive its first public hearing at one of the city council's February meetings.

SCI Consulting for further cannabis ordinance and fee development.

The January 22 meeting was a short agenda that got everybody out the door by 6:58 p.m. Councilmember Douglas was absent.

By unanimous vote the council waived a second reading and adopted Ordinance 540, amending the municipal code and clarifying the way sewer service charges are assessed on multi-tenant commercial buildings.

Two other agenda items also received unanimous votes:

- The Village Oaks development (Iowa Hill Rd.) tentative subdivision map was extended for 12 months
- The council authorized the city attorney to draft a letter stating that the City of Colfax assumes financial responsibility of removing the Chinese Monument. The city is being considered as a permanent site for the Chinese Monument to the contribution of Chinese workers to the building of the first Transcontinental Railroad.

Chinese Monument founder, Steven Lee, had requested a letter from the city attorney stating the City of Colfax will assume the responsibility for removing the monument in the future, however unlikely that might be.

The suggested monument location in Colfax would be on the Depot Green.


It's Been Wet, But More Rain Needed



Colfax has received 20.5 inches of rain so far this season, which is five inches under what we had at the end of January 2019. It took a wet February last year, when 20 inches fell through the month, to boost the total to a low-normal of 45 inches heading into March. We eventually finished the wet season last year with 62.7 inches, but it took a wetter than normal May and a final June thunderstorm to get us there.


Placer County's Flag Has Been Redesigned



City's New Broadcast system for meetings

Have you checked out city hall's new and vastly improved council meeting broadcast system? If not, it's as easy as going to the city's Web site, http://colfax-ca.gov/, clicking the 'Watch Meetings' button on the Home page, then reaching for the popcorn.

The new system was developed by Vision Quest, the city's IT service provider, and debuted at the last meeting in December after being in development for six months.

City manager Wes Heathcock said all of the system hardware and installation cost \$4,000, and that the subscription for the Boxcast video streaming service will run another \$1,200 a year. That includes two cameras, with one feeding Wave and the other feeding the city Web site.

Other system features include:

- The ability to show either the council chambers or switch to a view of the chamber video screen so that viewers at home can also watch and follow along with presentations being shown the council.
- Much improved sound from all microphones in the council chamber.
- Meeting videos will be archived for 90 days on Boxcast, and essentially forever on YouTube.
- Closed captioning for the hearing impaired is also available.
