

### Mayor's Gavel Passes To Lomen, Pioneer Expansion Approved

The new mayor of Colfax, Sean Lomen, mayor pro tem Trinity Burruss, and new council member David Ackerman all took their oaths of office at the end of the December 16 city council meeting, the only meeting of December 2020. Congratulations to them all.


The swearing-in ceremony closed a meeting that worked through a busy agenda over the course of three hours.

Retail Strategies, a business recruiter, started things off with an extensive presentation on marketing strategies for bringing new businesses to the Colfax I-80 business corridor. Presenter Matt Tate said that local available I-80 frontage property was "sitting on go," and would benefit from accelerating growth along I-80 between Roseville and the summit.

Next up was a public hearing on Osborn Engineering and Construction's site plan and design review approval for two buildings at 1836 Canyon Way. After a brief discussion the council went with staff's recommendation to approve on a 5-0 vote.

Pioneer Community Energy Joint Powers Authority (JPA) was back before the council urging a "yes" vote on a resolution approving the expansion of the existing, six-member JPA. (See Colfax Connections, December 2020 issue.) Pioneer made a council presentation on the expansion in October. Pioneer

The Mayor's Corner

Over the last few years your City Council has been working with our partner agencies to better protect our community from the threat of catastrophic wildfires that are becoming the norm in California.

The North Fork of The American River Shaded Fuel Break and fuel reduction projects at our wastewater treatment facility and closed landfill site are part of this effort.

In 2020 council approved a hazardous vegetation ordinance, which took effect on January 1, 2021. The goal of this ordinance is to help provide property owners with the information they need to keep their properties fire safe. It will also provide city staff with guidelines and tools they need to insure that the homes and businesses in our community can be protected should a wild-fire threaten Colfax in the future. The City Council will also be hosting a public workshop during the first quarter of 2021 to take a holistic look at the City's current fire protection model and what can be done to improve fire services for our community. We will have representatives from CAL Fire/Placer County Fire, Placer Hills Fire Protection District, Placer County Resource Conservation District, the state

insurance commission, and local insurance companies attending to help us improve fire services in our City.

Our goal is to put a fire protection plan in place that will provide the best fire service while improving our community's fire insurance rates. We encourage the community to attend this workshop.

# Fire Protection Agreement Due To Exprire On June 30 this Year


Currently the City of Colfax (City) and Placer County share in a Fire Protection Agreement (FPA) that directs and provides a professional and fulltime administrative and operational oversight of the Colfax Volunteer Fire Department by CAL FIRE/Placer County Fire Department (PCFD).

This FPA, which has been in place since 2001, has been renewed by the City every three years since 2003 and is set to expire on June 30, 2021.

Through this FPA Colfax receives Chief Officer or Company Officer Command and Control of all emergency incidents as the Incident Commander within the City. It also provides administrative and operational oversight of its volunteers, and management of the Volunteer Department including training, apparatus and equipment maintenance and purchasing.

Although this agreement has been in place since 2001, the City of Colfax, Placer County and CAL FIRE/PCFD have for many decades shared the professional emergency services provided to the

#### Colfax Hazardous Vegetation Ordinance Is Now The Law

The city's hazardous vegetation ordinance took effect on New Year's Day.


The ordinance declares hazardous vegetation and combustible materials within 100 feet of a structure, or within 10 feet immediately adjacent to roadways serving as primary ingress and egress routes as a public nuisance that must be abated by the property owners to create defensible space around those structures and roadways.

The ordinance also requires:

- All trees, hazardous vegetation and ladder fuels within defensible space areas to be pruned and
- removed to a minimum height of 15 feet above the ground.
- Removal of tree limbs extending to within 10 feet of a chimney or stovepipe.
- Removal of all climbing vines from trees and structures.
- Maintenance of all vegetation adjacent to or overhanging a structure free of dead or dying wood within a 10-foot distance from the structure.
- Keeping roofs and rain gutters free of leaves, pine needles and other hazardous material.

If a property owner fails to abate hazardous vegetation, or to maintain structure and roadway clearance requirements, the City may abate the nuisance without further notice at the property owner's expense.

# **Creative Corner Is Still Going Strong**


Creative Corner Arts & Crafts Co-op, 55 S. Main st., started out as Connie's Decors Holiday Co-op Boutique in 2010. The shop took on its current name after the holiday the next year.

Connie is Connie Heilaman, Certified Interior Designer since 1976. She is the founder and creative force behind Creative Corner. At this time Connie's Decors designs only windows and drapes. In the boutique Connie displays her own watercolors and acrylics, jewelry, floral arrangements, greeting cards and more.

The other vendors are Chuck Borgandt, ceramics and Barbara Hoffman, art; Pam Catrambone, sewing projects and knitted items; Anna Anderson, knitted items and covid face masks; Shirley Williams, painted glassware and cards; Peggy Evanoika, "Mountain Soaps" soaps, essential oils, personal products.

Each member of the co-op commits to staff the store one day a week. While there, they represent all the store's products, not just their own. The shop also has a selection of beautiful, discounted fabrics, accent pillows and area rugs. It offers gift certificates too.

county by CAL FIRE. Colfax has benefitted from the guaranteed response of the CAL FIRE/PCFD engine from the Colfax CAL FIRE/PCFD Station 30 to every emergency in the City.

This benefit was strengthened even more in 2019 when CAL FIRE re-funded the second CAL FIRE engine at Colfax Station 30 that was lost to state budget cuts in 1992. Indirectly through this agreement the City not only has access to these two paid fire engines at Station 30, but also, if needed:

- 20 CAL FIRE Engines
- 6 PCFD Engines
- 2 PCFD Truck Companies
- 1 PCFD Hazardous Material Response Team
- 1 PCFD Technical Rescue Team
- 7 CAL FIRE Type 1 Fire Crews
- 3 CAL FIRE Bull Dozers
- CAL FIRE Fixed Wing and Rotor Wing Aircraft
- Regional access to additional Local Fire Department resources.

Discussions are currently going on between Colfax city council and staff, and the CAL FIRE/PCFD Administration looking for ways to better support the city's volunteer department. It is the goal of the fire department's administration to seek the best model for our entire fire department, including both our Volunteers and the CAL FIRE/PCFD paid staff.





executive director Don Eckert summarized the main points again for the council, adding that the other JPA members had voted to approve. Colfax joined them after a brief council discussion and a 5-0 vote.

The last item of council business dealt with a two-part Colfax Volunteer Fire Dept. item that included: the potential purchase of a Tactical Water Tender that would cost \$375,000, and the potential for merging fire services with Placer County. After some brief discussion,

council member Fatula said the council needed more information and suggested a public workshop in January. (For more information on this isue see Mayor's Corner on page two.)
