New Owner Of Colfax Hotel Lays Out Development Plan For Council

September 8, 2021 City Council Meeting – After more than 30 years of sitting vacant in various states of partial construction, while being passed

from one failed owner to the next, it now appears the historic Colfax Hotel at 10 E. Grass Valley St. may finally have an owner with a realistic plan to re-open its doors.

Leif Lowery, owner of Vintage Development, the Dutch Flat Hotel and Miner's Camp in Foresthill, has purchased the property.

"This is the first viable owner we've had in years, and they have a rock-solid plan," said councilman Joe Fatula during an information workshop on the new owner and the hotel's future.

Lowery said that his intent is to renovate and, to the extent practical, restore the historic char-

acter of the building. Because interior framing for a prior senior housing proposal by previous owners is mostly complete on the second and third floors, however, he said that he will be limited as to what he can do on those floors. Plumbing wastewater and vent lines are also installed in much of the second and third floor and much of the plumbing for the fire suppression system is also installed.

The council expressed enthusiastic support for the proposal, but no action was taken as this was an information item to receive council and public input.



The meeting's final piece of council business dealt with the city leasing the vacant lot at 101 Railroad St. from Union Pacific (UP). The city initially approached UP in 2018 about leasing the property, but opted not to after the railroad set the price at \$9,000 per year. Earlier this year the city re-opened negotiations and got the price whittled down to \$5,000.

Control of the property will give the city extra downtown parking and will allow abatement of the ongoing nuisance the weedy, dusty lot poses. The council voted unanimously to seal the deal.

The council's second meeting in September was cancelled. The next scheduled council meet-

ing will be October 13, 2021.

August 25, 2021 City Council Meeting – Thirty minutes gavel to gavel may not be the shortest city council meeting on record, but it definitely puts the August 25 meeting in the running. A slim agenda and having only three members – Lomen, Fatula and Mendoza – present helped speed

things along.

During agency reports Colfax Area Chamber of Commerce president Sally Laughlin announced that all Chamber events would be postponed until after Railroad Days (Sept. 18-19) because "the COVID wave is getting pretty big."

The council passed the Consent Agenda on two votes after councilmember Fatula pulled the minutes of the previous meeting to adjust the wording of a quote attributed to him.

There was no public comment.

The night's one item of council business dealt with the River Fire Emergency Lodging Reimbursement Funding Program, for Colfax residents that were included in the mandatory evacuation order on August 4-6.

City manager Wes Heathcock explained that those residents were forced to leave their homes and seek shelter elsewhere. Because Placer County's evacuation center has restrictions on housing animals and residents with COVID-19, some Colfax residents sought shelter in local lodging facilities. That in turn placed many of them under an unexpected financial hardship.

The city manager's response was to implement

the River Fire Emergency Lodging Reimbursement funding program to give those residents some financial relief.

To be eligible, residents must meet the following conditions:

- your residence is within the red mandatory evacuation area and your property is within Colfax City limits.
- you incurred temporary shelter/lodging expenses during the evacuation period of August 4 –6th.
- verification of expense receipts is required.
- \$500 maximum benefit per household.
- the program will not exceed \$10,000.
- applications will be accepted until 8/31/21 or until the funding is exhausted.

Councilmember Fatula moved to increase the program funding amount to \$20,000, and requested food reimbursement for displaced residents during the mandatory evacuation. After councilmember Mendoza clarified that members of the council could not participate in the program, the council approved the program on a 3-0 vote.

City Council meetings in October are scheduled for 10/13 and 10/27.


Sutter Roseville Medical Center recently experienced its busiest day in the Center's history, driven by the surge in Covid-19 cases. Placer County's Director of Health and Human Services Dr. Rob Oldham provided the Board with an update indicating the situation from hospital executives in the region is "dire".

The surge is very real here in Placer County. When Board-Chair Robert Weygandt and I toured Sutter Roseville Medical Center with their entire management team, we saw the lobby and hallways were full of non-critical patients waiting to be seen because all their rooms were full to capacity with Covid-19 patients.

The Delta variant is very different, much more contagious and our hospitals are seeing younger patients admitted. The staff indicated that nearly 90% of those currently hospitalized with COVID are unvaccinated. If you are not already vaccinated I encourage you to schedule a vaccination appointment today.

And wear a mask to not only protect yourself - but your family, friends, and our entire Placer community.






Roundabout Sign Nearing Completion

The 'River Fire' Was Stopped By A Rapid, Massive Response

A week after the 'River Fire' exploded out of the Bear River campground just outside of Colfax, firefighters had achieved 85% containment with 2,619 acres burned.

Driven by strong afternoon winds on August 4 the fire grew so fast and so large original estimations of its eventual size ranged from 10,000 to 15,000 acres. That didn't happen because the original call-out brought in 68 engines, 30 water tenders, 22 hand crews, 18 bulldozers, 15 aircraft and 744 firefighters and support personnel.

"For several hours on August 4 this was the number one priority fire in California, drawing resources from as far away as CAL FIRE's Riverside Unit to the South and diverting resources from the Dixie Fire in the North," said Brian Eagan, CalFire Battalion Chief/Colfax, Alta Battalion.

At a public meeting in Colfax on August 7 fire officials said that the The 'River Fire' Was Stopped By A Rapid, Massive Response cost of suppressing the fire stood at \$7.3 million, and that air tankers had dropped 292,000 gallons of retardant on the blaze in the first six hours.

At the height of the fire, over 2,600 residents of Placer and Nevada Counties were evacuated, with all evacuation orders and warnings lifted by August 10.

After a complete damage assessment by August 11, 102 residential structures, one commercial structure and 39 other structures were destroyed. Another 21 structures were damaged in Placer and Nevada counties.

The fire was completely controlled on August 13. During the height of the River Fire on August 10 and 11, firefighters quickly snuffed two fires on Robbers Ravine Rd. near Cape Horn, and a larger fire in Yuba County known as the Glen Fire.

As tragic and as devastating to the com-

munity and environment as the fire was, the outcome could have been much, much worse. While on the verge of a record setting drought year with fuel conditions at critical levels for the weeks prior to the fires, there are success stories to be recognized.

One of the success stories is the low number of injuries and no loss of human life. Only two Fire Fighters and two Civilians suffered injuries through the course of the fire.

The routine Unified Command training of the Placer County Sherriff Office with CAL FIRE/ Placer County Fire Department provided the framework for local and regional first responders to initiate evacuation orders and warnings in both counties within the first 20 minutes of the River Fire's start.

"Our community members have an equal part in this success story as well," Eagan said. "If it had not been for their preparedness, calm and orderly evacuations first responders would have had to spend more time evacuating residents and less time fighting the fire."


