

## Auditor Says The City Is Doing "Very well"


The city received a clean annual audit report at its January 12 meeting.

Among the highlights presented to the council by Richardson and Company, LLP (Sacramento) managing partner and auditor, Ingrid Sheipline, were:

• General Fund revenues exceeded budget by \$280,000 from higher sales taxes and building permits, while expenses were less than budget by \$42,000 due to lower payroll expenses and capital outlay costs.

• Sewer Enterprise Fund revenues exceeded budget due to unbudgeted connection fees,

insurance refund and grant revenue for WWTP improvement planning and Pond 3 repairs while personnel and Operation and Maintenance costs were lower than budget.


• Liabilities – Debt of \$7,198,000 to fund sewer system upgrades. Unfunded pension liability is \$146,000. No retiree health benefits, so no liability recorded.

• Total revenue from all sources was \$6,389,097 of which \$841,592 was from capital grants and contributions. Total expenses from all sources were \$4,763,091.

Sheipline said that she had found no internal control weaknesses, and that the city complied with all relevant laws and regulations.

She also reported no difficulties in performing the audit and no unusual accounting practices.

"Overall it was a very clean audit and the city is doing very well," Sheipline said.



#### **PROGRAM EXPENSES**

The council approved the quarterly report on Sales and Use Tax revenues for first quarter of fiscal year 2021-2022. As of the end of September 2021, sales tax revenues from sales made within the city jurisdiction decreased 22% as compared to the same quarter last year. It is the lowest quarter reported since 2017.

#### At its second meeting of the month on January

**26**, the council approved the final paperwork to close out the Community Development Block Grant (CDBG) that provided Subsistence Payment grants to Colfax residents that were eligible for the COVID-19 Relief Grant Program (Program). Two grants totaling \$16,409.27 were awarded.

City Manager, Wes Heathcock, was authorized to receive a Caltrans Sustainable Transportation

Planning Grant for \$211,030 to prepare a Downtown Connectivity and Main Street Improvement Plan. There is a required match of 11.47% (\$27,341) from the city. The plan will include concepts and identify investments to improve the accessibility, visibility, safety and appeal of the historic downtown for residents, visitors, businesses and property owners.

Cannabis will be making a return to the council agenda after Jim Dion, owner of Golden State Patient Care here in Colfax, petitioned the council from the public comment podium for a hearing on whether to allow him to also sell recreational cannabis. The council directed staff to agendize it for a future meeting.

#### What's happening now in Placer County? COVID-19 Update

Cases in Placer County are now surging significantly.

There were 42,022 confirmed COVID-19 cases in Placer County as of Dec. 31 (data pulled Jan. 4). Cases surged at the end of December after decreasing through November. December 2021 saw 401 cases on the 30th, the highest single-day new case count since the beginning of the pandemic up to that point (data pulled on Jan. 7).

As of January 7, 2022 the highest single-day case count has again been exceeded at 532 new cases on Jan. 3.

An individual who tests positive on multiple occasions is only counted as a single case, except if the reinfection surveillance definition is met.

As of Jan. 3, 2022 Placer County has received reports of 492 COVID-related deaths.


• 193(39%) were residents of long-term care facilities.

• 49% were under the age of 80; 18% were under the age of 65.

• At least 93% of those who died had at least one confirmed underlying health condition. (36 deaths are pending for this data).

# **Placer County** Chipper Program

Operated by:



The Chipper Program provides a low-cost, residential chipping service to help landowners manage their vegetation and meet defensible space goals.

#### Please Read:

- Chipping will occur alongside the road/driveway or other areas that allow the crew to work around the vegetation piles safely. No business or commercial use.
- Please stack vegetation with the cut ends facing one direction that is easily accessible by the Chipper vehicles. Stem diameters must be less than 12 inches.
- Please no poison oak, scotch broom, or vines, such as blackberry and grapes.
- All chipped vegetation will be blown back on the property.
- Chipping is completed on a rotational basis throughout the county to save on fuel costs. No appointments are made.
- After chipping, the crew will leave an invoice at your door. The minimum invoice will be for one hour of service, at the cost-share rate of \$80/hour.
- Cost-share fees may be waived for homeowners who either: ...possess a disabled/handicapped vehicle placard, or
  - ...have a household income not exceeding the "Very Low Limit" as defined by the State of California Department of Housing and Community Development: www.placerrcd.org/fees-waived






