# Driest January–March In California's History

Thanks to the 29.7 inches of rain and snow that fell on Colfax in October, November and December, we entered the New Year feeling hopeful that more of the same would be coming.

We were wrong. The first three months of 2022, that were recorded as the driest January–March period in state history, produced only an additional 2.5 inches total.

Nearly all of that came during one week in March, a month that normally receives an average of 9 inches of precipitation. What we got was barely enough to hold the dust down for even a day and left us with a season total of 33.3 inches.

Over the last five years April and May together have averaged 7.3 inches total, and although this April started slow a string of six wet days in the middle of the month produced 6.9 inches of rain, raising the season total to 40.2 inches.

In light of another historically dry winter, leading into what will be another hot, dry summer, the Placer County Water Agency (PCWA) has published some water saving tips for county residents.

## **Chicken Ordinance Gets Reintroduced**

After being sent back to the Ad Hoc food waste reduction committee for revisions and modifications at the city council's December 8 meeting, a proposed ordinance for reducing food waste being sent to the county landfill was re-introduced at the council's April 27 meeting. It was the council's only meeting in April.

The Ad Hoc committee was composed of council members Fatula and Lomen. Due to the passage of time and the scope of changes made by the ad hoc committee, re-introduction of the proposed ordinance and another public hearing were required. Changes made to the draft ordinance are as follows:

- This will be Ordinance No. 547 because Council adopted Ordinance No. 546, which implements changes required by SB 1383 (Organic Waste), in the interim.
- Section 6.20.020 C 1 a was amended by striking the sentence that read "This section is not intended to regulate the keeping and raising of chickens on agricultural zoned parcels but it is intended to regulate the keeping and raising of chickens on all parcels zoned residential R-1."
- Section 6.20.020 C 2 b now requires chicken coops to contain a slide-out manure tray to facilitate the removal of manure.

- Section 6.20.020 C 2 e allows but does not require chicken runs to include a roof to provide protection from inclement weather.
- Section 6.20.020 C 3 c will limit the maximum number of chickens to eight regardless of regulated parcel size.
- Section 6.20.020 C 3 d prohibits roosters but the sentence requiring removal of roosters as soon as they are of adequate age to be identified as such has been deleted.
- Section 6.20.020 C 3 e (i) will allow coops to be constructed within five feet of a property line but retains a minimum five-foot setback from buildings or structures on adjacent property. City of Colfax Ordinance 547 amending CMC Chapter 6.20 "Limitations on Number of Animals (Chickens) Staff Report April 27, 2022.
- Section 6.20.020 C 3 e (iii) has been modified to allow coops to be constructed of pallets, scrap wood or scrap metal so long as an eyesore or public nuisance is not created, as determined by the City Inspector.

- Section 6.20.020 C 3 e (vii) requires all coops to contain a manure tray to facilitate easy cleaning.
- The one-time administrative permit fee in Section 6.20.020 C 4 has been reduced from \$25 to \$1.
- The discretion to prosecute violations as infractions in Section 6.20.040 C has been eliminated so the only possible criminal penalty is misdemeanor prosecution.

This ordinance was prompted by the passage of SB 1383, which requires persons generating organic waste to comply with local requirements for collection and recovery of organic waste onsite, and with the use of collection services or through self-hauling.

"Organic waste" includes food and green waste but is also broadly defined to include materials such as food scraps, coffee grounds, peelings, vegetable trimmings, bones, bread scraps, and used pizza boxes.

The net effect of the law and its implementing regulations is that organic waste, including food waste, can no longer be placed in the landfill and must be diverted through a high diversion recovery facility or single source separation waste process.

After a brief council discussion and one public comment opposed to the ordinance, councilmembers Lomen and Fatula respectively moved and seconded approval. The vote was 4-1, with Mayor Burruss in the minority.

# **Council Business – Green Machine Changes Its Mind On July 3RD**

During agency reports at the March 23 city council meeting, the Green Machine announced it would not be overseeing the Third of July city event in 2022.

After a special meeting with organization members, however, the board changed its mind and agreed that if the city put up \$10,000 for the fireworks, and its usual \$1,000 event donation, that the Green Machine would produce the July event.

During the ensuing discussion all council members voiced support for giving Green Machine the requested funding.

Mayor Burruss went so far as to suggest that funding two fireworks displays each year (July 3 and Winterfest) should be a regular city budget item.

"It's a city responsibility regardless of what civic group is producing the event," she said.

The motion to fund the \$11,000 passed on a 5-0 vote.



#### Water saving tips from page 1

- Replacing older sprinklers with more efficient nozzles.
- Checking the soil moisture before turning sprinklers on. PCWA customers can also pick up a moisture meter from the agency's main office at 144 Ferguson Road in Auburn or at a PCWA event.
- Limit watering landscape to three days per week.
- Be sure to water trees, even if you cut back on watering your landscape.
- Putting down a layer of mulch such as rice straw or wood chips 2-3 inches deep to help retain moisture and keep plant roots cool.

On a final note, those of us that still have piles to burn are reminded that as of April 18 burn permits are required for the remainder of the burn season.

## **County Accepting Microbusiness Grant Applications April 25 - June 10**

Placer County is launching the second round of grant funding for microbusiness owners who may have missed their opportunity for a \$2,500 grant in the first round.

New applications for the Placer Micro Biz Program will be accepted starting April 25 through 4:49 p.m. on June 10.

Microbusinesses in Placer may be eligible for up to \$2,500 in grant funding. The grants are not loans and do not need to be paid back. The state provided Placer County with a total sum of \$412,500 in relief funds to award microbusinesses impacted by the coronavirus pandemic.

Placer launched the first round in February and in April awarded a total of \$137,500 to 55 recipients. The remaining sum of \$275,000 may

be awarded during the second round. To qualify, businesses must have five or fewer employees and a household income of less than \$50,000 a year.

An eligible business must also have been in operation by the end of 2019. There are a few additional eligibility requirements so please review before submitting an application.

The Placer County Board of Supervisors on Jan. 25 approved the grant program and directed the Placer County Economic Development Office to set up and distribute the funding.

## **Expect To See Increased CHP Presence On County Roads**

The California Highway Patrol (CHP) will be increasing traffic enforcement on county roads following the recent approval of new contracts for the expanded service by the Placer County Board of Supervisors.

The approvals were in response to recent requests from residents for increased speed limit enforcement in communities spanning the county.

Contracts with the CHP's Auburn and Truckee divisions will fund up to \$190,000 in increased services for one year, starting June 1. A separate agreement up to \$10,000 with the Gold Run Division is still being negotiated.


Increased enforcement efforts will initially be focused on the unincorporated roadways with high traffic volumes and where the county's Department of Public Works has received concerns




from residents about speeding.

Traffic safety in Placer County is the shared responsibility of the CHP and the Department of Public Works. Public Works continually evaluates and implements safety measures like speed limits, intersection controls and speed bumps, and works to educate the community about safety concerns.




