### New City Manager Takes Over, Another Clean City Audit

The January 24 Colfax city council meeting opened with two city managers, but ended with one after interim city manager Mike Luken stepped aside, and new, full-time city manager Ron Walker took over.

The council gave Luken a plaque commemorating his time in office as thanks for stepping in after Wes Heathcock left for a new position in Loomis.

The council received a glowing annual audit report, delivered by Ingrid Sheipline, managing partner for Richardson & Company, LLP.

She said the audit was "very clean and required no changes or adjustments, with strong positions in all reserve accounts."

She also applauded city finance director Laurie Van Groningen and Shanna Stahl, city administrative services officer, for their work and cooperation during the audit.

"There were no difficulties in obtaining documents and other materials required to complete the audit process.

### Placer County Adopts Voter's Choice Act Election Model

Approved by the Board of Supervisors in the summer of 2023, the Placer County Elections Office has adopted the California Voter's Choice Act (VCA) election model to provide our eligible voters with more choice and control over their vote.

Moving to VCA means Placer County will have fewer machines in fewer locations, the ability to verify a voter's eligibility and vote history in real time, and the capability to provide a paper ballot to every voter at their request.

The Placer County Elections Office believes this will not only increase voters' access to in-person voting and ballot drop-off, but will also increase their overall confidence and trust in Placer County elections.

This decision to transition to the new election model was primarily due to the increasing difficulty of recruiting 1,500+ volunteers and securing 200+ sites willing to host a polling place during an election. Moreover, polling places are quite restrictive in both voting time and location—voters can only cast their ballots in person at their assigned polling place on Election Day.



A move to VCA addresses both these issues, as this election model employs regional vote centers that are open for several days preceding an election and unrestricted to voters of a particular precinct. All voters can vote in person at any vote center.

Placer County will have 29 vote centers for the

draft Colfax Downtown Connectivity/Main Street Improvement Plan (Plan) took up the greater part of the meeting.

Paid for with a \$211,030 Caltrans Sustainable Transportation Planning Grant in 2021, the plan includes concepts and potential investments to improve the accessibility, visibility, safety and appeal of the historic downtown for residents, visitors, businesses and property owners.

CivicWell, formerly the Local Government Commission, was hired to prepare the grant application and then produce the Plan when funding was approved.

A non-profit company, Civic-Well was hired for its experience in bringing the public into planning processes, transportation planning and community design.

GHD Inc. was hired in 2022 to provide planning and outreach services.

The public was brought in as part of a steering committee, including interested residents, businesses, the Colfax Area Chamber of Commerce, the Colfax Area Historical Society, local artists, and public safety representatives.

The committee was led by Councilmember Hillberg and Mayor Pro Tem Lomen.

The final draft report on the Plan was the centerpiece of the public workshop, and was previously reviewed by the steering committee, council ad hoc committee and staff.

The workshop was to solicit comments and concerns before

bringing the Plan back to the city council in February for final council consideration.

The council adjourned the open meeting and went into closed session at 8 p.m.

March 5, 2024 Presidential Primary Election. Depending on the location, each vote center will be open for either four or 11 days, and all locations will be open from 8 a.m. to 4 p.m. every day, except for Election Day, when hours will be 7 a.m. to 8 p.m.

VCA also requires participating counties to provide at least one vote-by-mail ballot drop box for every 15,000 registered voters. Placer County has already met and exceeded this requirement each election since 2020.


In the past, vote-by-mail ballots dropped off at polling places or drop boxes on Election Day could not be processed until rosters had been verified, meaning they may not have been counted for weeks following the election.

However, recently passed legislation now permits voters to bring their vote-by-mail ballot to any vote center and use the ballot scanner to have it counted on site, ensuring it will be included in the preliminary results released on Election Night.

A list of vote center and drop box locations will be included in your Placer County Voter Information Guide (look for it in the mail the last week of January), your vote-by-mail ballot packet (mailed Feb. 5) or on the Placer County Elections website (www.placercountyelections. gov.)

#### Emergency Preparedness | OES Reorganization

• Championed an innovative model integrating the Sheriff's Office and Placer County Fire Department into the Office of Emergency Services. This facilitates more efficient planning, communication, and response during emergencies.

#### Public Safety Prioritization | DSA Agreement, Fentanyl Convictions, Body-Worn Cameras, Airplane Hangar

- Supported a new labor agreement with the Deputy Sheriffs' Association, boosting salaries for recruitment and retention.
- Supported the DA's pursuit and prosecution of fentanyl dealers first murder conviction in the State.

• Approved the acquisition and implementation of body-worn cameras, and a larger hangar for PCSO's fixed wing aircraft.

#### Investment in Forest Health | LandTender

• Continued support for forest health projects and a contract with LandTender for complete mapping of forest lands to inventory and prioritize forest health projects.

#### Transportation | Rail Service

• Convened meetings with local, state, and agency representatives resulting in grant funding to study increased passenger rail service from Roseville to Reno.

## Fire Safety | Insurance, Defensible Space, I-80 Fuel Reduction

- Continued efforts with the State addressing the high costs, unacceptable delays, and numerous errors experienced by constituents and brokers in California FAIR Plan.
- Supported funding to assist with defensible space for individuals that may be disabled, seniors and low income.
- Supported Caltrans' fuel reduction project that aims to minimize the impacts of truck fires along I-80 by creating shaded fuel breaks.







