Sidewalk Maintenance/Repair Ordinance Is Still Pending

The sidewalk repair and maintenance ordinance almost made it through its second reading at the **January 22 city council meeting**, but was sent back to city staff for more clarification on determining whether trees causing problems are owned by the city or the property owner. At issue is the question of who pays for sidewalk repairs due to damage caused by tree roots.

Council member Trinity Burruss was not present for the meeting, but called in on the phone an hour after the meeting began.

After sending the sidewalk ordinance back to staff, the council heard a presentation on the Seniors First – Placer Rides Program, which helps county senior citizens get around using volunteer drivers who are then reimbursed for mileage. (See page 5 for more information).

The council also approved its committee assignments for 2025 on a 4-0 vote before moving to its last piece of official business regarding temporary improvements to the outdoor dining area on N. Main St.

The lengthy discussion between the council, business owners and members of the public boiled down to a choice between one large outdoor dining area, or three smaller ones anchored to specific businesses. In the end, the council directed staff to set up a public workshop in late February to try and work out a plan.

The January 8 Colfax City Council meeting started on time with Mayor Pro Tem Caroline McCully holding the gavel, as Mayor Sean Lomen was absent. All other council members were present.

The consent calendar passed on a 4-0 vote, and Calfire reported that four strike teams from Placer County were working in Los Angeles County.

An audit report on the fiscal year ending June 30, 2024 was the first of two presentations on the agenda. Richardson & Co. managing partner/auditor Ingrid Sheipline said the audit showed the general fund and sewer fund each stood at slightly over \$3 million, a minimum pension liabilty, and a state loan of \$6.2 million that's being repaid at a rate of \$374,000 a year for another 16 years.

Colfax Lions Need A Few Good Volunteers

Where have all the volunteers gone? That's the question that has Paul 'Red' Houck, president of the Colfax Area Lions club, worried these days.

"People aren't volunteering the way they used to anymore," said Houck. "And it's not just the Lions. I'm probably speaking for every other non-profit organization in town. People just aren't joining."

Houck illustrates the problem with the situation the Lions currently face. "This club's 100year anniversary in Colfax will be in 2028 and, frankly, I don't know if we will make it to that."

He said that three years ago the club had 39 members, but now has 22. And two of those live out of state, whittling the number of available hands on deck to 20.

Sheipline called it a "clean audit requiring minimum adjustment" and applauded the city's administrative services officer, Shanna Stahl, for her "excellent work" and finished saying "the city's in very good financial condition."

Following no questions from either side of the room, the council voted 4-0 to believe her and moved on to the second presentation for the winners of the city's first annual holiday outdoor light contest. The first place winner of a \$50 MarVal gift card was Jeff Hoge, 48 West Grass Valley St.; Ken & Fabiola Morse at 102 Oak Hill St. took second and a \$30 MarVal gift card; and Karl & Debra Fullenwider at 314 N. Main St. took third and a \$20 MarVal gift card. Fourteen residents entered the contest.

The proposed sidewalk repair maintenance and liability ordinance passed its first reading after some discussion. City planning consultant Kathy Pease walked the council through the changes they'd requested at the December 11 meeting, displaying a list that included:

• Extension of the time for repairs from 60 to 90 days.

• Allowance for property owners requesting an extension beyond 90 days.

• Flexibility on payment options including voluntarily adding costs to the tax rolls.

• Definition of 'good faith effort' and standards of repair.

• Consideration of property owners dealing with

- corners or on hillsides.
- Consideration for dead end sidewalks.

During a brief discussion, council member Larry Hillberg voiced concerns over how widely information about the proposed ordinance had been disseminated, but he joined the majority in a unanimous vote.

There were two items of official council business on the agenda. The first was a city procurement policy amendment that would raise the city manager's purchase authority to procure supplies, equipment and other services from \$10,000 up to \$25,000. With little discussion the item passed on a 4-0 vote.

The second item was a request by Golden State Patient Care (GSPC), the city's sole cannabis retailer, to terminate the semiannual financial audit and physical inspections that are costing GSPC \$11,000 a year.

SCI, the consultant that has conducted the audit and inspections since 2019, told the city that no deficiencies have been found to date, and that GSPC is, and has been, in compliance with all state and local regulations. GSPC founder and owner Jim Dion reminded the council that he has been in compliance since he opened 22 years ago. After no one from the council or public spoke against the request, the council voted 4-0 to grant it.


Government works best when we collaborate with a diversity of perspectives and strive for common understanding. Your involvement can truly make a difference.

Placer Rides: Free Rides to Your Important Appointments



WHAT IS PLACER RIDES? Placer Rides helps you get to where you want to go, when you want to go and with whom you want to drive you... all for FREE! It's a mileage reimbursement program where where you can use private cars and volunteer drivers you trust and feel safe with.

WHO CAN USE PLACER RIDES? You can use this service if:

- · You live in Placer County.
- · You are 60 years or older, or have a disability, or are low-income.
- · You have no other way to get to your essential appointments.

WHAT TYPES OF RIDES ARE COVERED?

- · Medical appointments (doctor, dentist, vision, therapy, etc.)
- · Errands (grocery shopping, pharmacy, bank)
- · Trips to bus/train stations or airports
- · Other necessary trips as approved by Placer Rides staff

HOW DOES IT WORK?

- Volunteer Drivers: You'll need to find someone you know (family, friends, neighbors) to drive you. These volunteers can get reimbursed for the miles they drive.
- Flexible Scheduling: You and your volunteer can agree on a time for the trip, and you
 can even make multiple stops.

IMPORTANT DETAILS

- · Monthly Limit: You can use Placer Rides for up to 200 miles per month.
- No Other Options: This is a last-resort service—only use it if you have no other way to get to your appointment.
- Service Area: Trips must start and end in Placer County, but you can also go to hospitals in Sacramento County, like UC Davis or Sutter Sacramento.

HOW DO YOU SIGN UP?

- 1. Fill out the Placer Rides Application Form.
- 2. Submit the form to Seniors First by mail or email.
- 3. If approved, you'll get a welcome packet and reimbursement forms.
- 4. You will be reimbursed for up to 200 miles each month. You can get \$0.67 per mile for trips.

"And of those, about 12 are active because they are physically still able to do it," he said. "Three years from now the majority of our members will be over 80. Our youngest member right now is 45. And as much as we have tried to get people to join they just aren't interested."

And while volunteers and memberships are declining, he said requests from other groups for help are increasing. After listing some of the many school programs the Lions support, from buying sports equipment to providing various scholarships – including a Kindle reading program in Chicago Park – Houck says, "If the Lions cease to exist the scholarships won't be there anymore because all of the fundraisers we do for the schools won't happen."

It clearly frustrates him. "In our generation we were taught to give something back to the community that gives to you. Now it's a different world than the one we grew up in.

"My big point is that I don't really care if you become a Lion, just come in and volunteer to help out. It's as simple as that."
