

**RECOMMENDED ACTION:** Adopt Resolution \_\_\_-2022 authorizing remote teleconference meetings pursuant to Government Code Section 54953(e) [AB 361].

### Summary/Background

The proposed Resolution, if adopted, will authorize the City Council to conduct its meetings virtually or in person under the teleconference rules contained in Government Code Section 54953(e).

On March 4, 2020, the Governor proclaimed a state of emergency to address the threat of the COVID-19 pandemic. That proclamation remains in effect.

On March 17, 2020, Governor Newsom signed Executive Order N-29-20 which allowed Council to meet virtually under relaxed teleconferencing rules. Council did so until Executive Order N-29-20 expired on September 30, 2021, and was replaced by different rules under Government Code Section 54953(e) [AB 361] effective October 1, 2021. Council initially elected to resume meeting in person, but the persistence of the COVID pandemic has prompted Council and staff to consider resuming its virtual meetings.

Government Code Section 54953(e) authorizes Council to use teleconferencing to hold its meetings during a proclaimed state of emergency when state or local officials have imposed or recommended measures to promote social distancing. "State of Emergency" is narrowly defined such that one only exists when the Governor has proclaimed one under the authority of Government Code Section 8625, which occurred on March 4, 2020, and remains in effect.

If Council adopts the recommended Resolution, meetings must meet the following requirements:

- 1. Agendas and notice of the meeting must be posted, but not at all teleconference locations. (GC 54953(e)(2)(A)).
- 2. Members of the public must be allowed to access the meeting and address the Council. The agenda must (1) include notice of the means by which members of the public can access the meeting and comment, and (2) identify and include an opportunity for all persons to attend via call-in option or internet-based service option, but the City is not required to provide a physical location from which the public may attend or comment. (GC 54953(e)(2)(B)).
- 3. Teleconference meetings must protect the statutory and constitutional rights of all parties and members of the public appearing before Council. (GC 54953(e)(2)(C)).

- 4. If a disruption occurs that prevents the city from broadcasting the meeting or that prevents the public from participating or commenting using the call-in option, no further action on the agenda items can be taken until the disruption is remedied. (GC 54953(e)(2)(D)).
- 5. The City cannot require public comments to be submitted in advance of the meeting and must allow for comments to be made in "real time". This does not require the city to provide a physical location from which the public may attend or comment. (GC 54953(e)(2)(E)).
- 6. GC Section 54953.3 precludes the City from requiring meeting attendees to register his or her name or to provide other information, complete a questionnaire, or fulfill any other condition precedent to attendance. AB 361 provides that individuals who want to provide public comment through the use of an internet website or other online platform not under the City's control may nevertheless be required to register as required by that third-party internet website or online platform to participate. (GC 54953(e)(2)(F)).
- 7. Colfax takes public comment separately on each agenda item so it will have to allow a reasonable amount of time per agenda item for the public to register or be recognized for the purpose of providing public comment. (GC 54953(e)(2)(G)(ii)). This generally applies to the public comment period on matters within the City's subject matter jurisdiction.
- 8. The following findings must be made within 30 days after teleconferencing under AB 361 for the first time without complying with Government Code Section 54953(b)(3) and every 30 days thereafter: (A) The Council has reconsidered the circumstances of the state of emergency, (B) Either the state of emergency continues to directly impact the ability of the Council to meet safely in person, or state or local officials continue to impose or recommend measures to promote social distancing. (GC 54953(e)(3)). Staff plans to place this periodic review on the Consent Calendar.

Staff is prepared to implement these requirements and will be available to answer any questions.

AUTHORIZING REMOTE TELECONFERENCE MEETINGS PURSUANT TO GOVERNMENT CODE SECTION 54953(e) [AB 361]

WHEREAS, Government Code Section 54953(e), as adopted by Assembly Bill 361 (AB 361) allows the Council to hold open meetings by teleconference without reference to otherwise applicable requirements of Government Code Section 54953(b)(3), so long as Council complies with legally-imposed requirements, there exists a declared state of emergency, and one of the following circumstances is met: (1) State or local officials have imposed or recommended measures to promote social distancing, (2) Council is holding the meeting for the purpose of determining, by majority vote, whether as a result of the emergency, meeting in person would present imminent risks to the health and safety of attendees, and (3) Council has determined, by majority vote, that as a result of the emergency, meeting in person would present imminent risks to the health and safety of attendees; and,


**WHEREAS,** on March 4, 2020, the Governor proclaimed a state of emergency pursuant to Government Code Section 8625, and that proclamation remains in effect; and,

**WHEREAS**, the City Council, having reconsidered the circumstances of the state of emergency, hereby declares that a state of emergency as a result of the threat of COVID-19 still exists and continues to impact the ability of members of the public, the City Council, Council subcommittees, City staff and consultants to meet safely in person.

### **NOW THEREFORE, BE IT RESOLVED BY** the City Council of the City of Colfax as follows:

- 1. The foregoing recitals are true and correct statements of fact and are incorporated into this Resolution by this reference.
- 2. The City Council hereby finds and declares the following conditions are met as required by Government Code Section 54953(e)(3):
- (i) The Governor of California proclaimed a state of emergency on March 4, 2020, pursuant to Government Code Section 8625, which remains in effect.
- (ii) The City Council has determined that, as a result of the emergency, meeting in person would present imminent risks to the health and safety of attendees.
- 3. The City Manager is authorized to utilize teleconferencing to conduct all City of Colfax public meetings pursuant to AB 361 and Government Code Section 54953(e).
- 4. In accordance with AB 361, the City Council shall reconsider the passage of this Resolution not less than every 30 days to determine whether a state of emergency continues to directly impact the ability of the Council to meet safely in person, or whether state or local officials continue to impose or recommend social distancing, until this Resolution is rescinded.

**RECOMMENDED ACTION:** Adopt Resolution \_\_-2022 authorizing the City Manager to execute a purchase agreement for one S66 T4 Bobcat Skid Steer Loader with six attachments, in an amount not to exceed \$120,325.

### Summary/Background

On February 23, 2022, City Council received a presentation from the Public Works Director on the December 26, 2021, Winter Storm After Action Strategy. The highlights from this presentation focused on the issues incurred by city staff during the storm, which included the need for improved communication, the shortage of snow removal equipment and safe collection of debris throughout the City. City Council resolved the need for additional safety equipment by approving the purchase of mobile signs for community notifications, a satellite phone, Bobcat Skid Steer and a front loader/backhoe to be allocated over fiscal years 2022-2023/2023-2024.

The Bobcat Skid Steer will fulfill an immediate need in Public Works maintenance operations. The acquisition of this machine with the selected attachments will allow for increased street maintenance in addition to increased mobility and effectiveness during snow removal operations. The price quotations include the purchase of a S66 T4 Skid Steer Loader and six attachments:

- Snow Pusher Pro, 8ft (96") Includes angle blade and removable pusher box.
- 72" Sweeper Bucket to be utilized for street maintenance
- 68" Heavy Duty Bucket for snow removal, street maintenance and general construction
- 24" Planer, High Flow Drum 24 Smooth Cut for the removal of road surfacing prior to road resurfacing.
- FC200 Flail Cutter to be used for vegetation management and creating fire breaks.
- R-Series Quick-Tach Water Kit is coupled with the sweeper and cold planer to reduce dust.

Staff solicited bids from the Bobcat Manufacturer for \$158,639 and from Sourcewell Purchasing Group for \$120,325 Sourcewell cooperative purchasing is a general ethos of collaboration, which helps governments identify best-in-class products, share research findings, and expedite purchases without requiring additional operating budgets or staff time.

Staff recommends that the City Council authorize the City Manager to execute a purchase agreement for one S66 T4 Bobcat Skid Steer Loader with six attachments from Sourcewell Purchasing Group, in an amount not to exceed \$120,325.

The total purchase agreement amount is \$120,325 to be funded by fund 100.







### Summary/Background

The resolution before Council, if adopted, will increase the time allocated to each speaker during public comment at regular Council meetings from three minutes to five minutes and reserve Council's discretion to adjust the time allocated to each speaker and each topic as circumstances warrant.

At the August 24, 2022, regular Council meeting, the Council expressed a desire to increase the time allocated to each speaker during the regular meeting public comment period from three minutes to five minutes. Council directed staff to research this issue and present proposed action for Council consideration. This resolution responds to that direction.

It appears that the current three-minute time limit resulted from informal direction given staff in 2009. The agendas prior to December 9, 2009, allowed 5 minutes per speaker under public comment at regular Council meetings. Effective December 16, 2009, the time was reduced to 3 minutes per speaker. The 3 minute per speaker time limit has been in effect since then. There was no formal action on the December 9, 2009, meeting agenda that would have formalized that change. There appear to have been no minutes prepared for the December 9, 2009, meeting. Staff believes that the reduction of 5 minutes per speaker to 3 minutes per speaker was done informally.

The draft resolution provides for 5 minutes per speaker for oral comments at regular meetings and 5 minutes for reading written public comments into the record when Council chooses to do so. It also reserves the City Council's discretion to adjust the total time allocated for public testimony on particular issues, and for each individual speaker, as circumstances may warrant on a case-by-case basis, and to revise the regulations as it deems necessary.

Staff will be available to answer questions or provide additional information.

### EXTENDING AND REGULATING PUBLIC COMMENT AT CITY COUNCIL MEETINGS

WHEREAS, Government Code Section 54954.3(a) requires every regular City Council meeting agenda to provide an opportunity for members of the public to directly address the City Council on any item of interest to the public, before or during the City Council's consideration of the item, that is within the subject matter jurisdiction of the City Council; and,

**WHEREAS**, Government Code Section 54954.3(b) authorizes the City Council to adopt reasonable regulations to ensure that adequate time is allowed for all speakers who wish to speak before the City Council, including, but not limited to, regulations limiting the total amount of time allocated for public comment or public testimony on particular issues, and for each individual speaker; and

WHEREAS, the City Council finds and determines that the following regulations will maximize the opportunity for members of the public to participate in and comment at regular City Council meetings while retaining adequate control to ensure that City Council meetings are conducted efficiently and effectively.


**NOW THEREFORE, BE IT RESOLVED** that the City Council of the City of Colfax adopts the following regulations regarding public comment at regular City Council meetings:

- 1. The Public Comment section of each regular City Council meeting agenda shall allocate five minutes each for members of the public to directly address the Council and make oral comments on any item of interest to the public that is within the subject matter jurisdiction of the City Council, and for reading written comments submitted by the public that the Council elects to read into the meeting record.
- 2. The time allocated to public comment shall be adjusted to comply with the provisions of Government Code Section 54954.3(b)(2), which requires allocation of twice the allotted time to a member of the public who utilizes a translator to ensure that non-English speakers receive the same opportunity to address the City Council, and to comply with other applicable provisions of law.
- 3. The City Council reserves its right and discretion to adjust the total amount of time allocated for public testimony on particular issues, and for each individual speaker, as circumstances may warrant on a case-by-case basis, and to revise these regulations.

### Summary/Background

The monthly financial report includes General Fund Reserved Cash Analysis Graphs and the City of Colfax Cash Summary Report (with supporting documentation). The purpose of these reports is to provide the status of funds and transparency for Council and the public of the financial transactions of the City. The reports are prepared monthly on a cash basis and are reconciled to the General Ledger accounting system, previous reports, and bank statements. Detailed budget comparisons are provided as a mid-year report and as part of the proposed budget process each year.


The attached reports reflect an overview of the financial transactions of the City of Colfax in August 2022. Some monthly highlights are listed below:

- August revenues included:
  - Allocation for Sales Tax revenues reported/paid to the State for the month of June 2022 (two-month lag).
- August expenditures included:
  - Ongoing monthly operating expenses
  - Approved capital project expenditures and inter-fund transfers for project funding.
- Negative cash fund balances at the end of August are due to timing of funding allocations and reimbursements:
  - Fund 358 CDBG Road Rehabilitation. This is a reimbursable grant final funding of grant is still pending. CDBG has approved start date of expenditures. Any unfunded expenditures would require allocation from General Fund.
  - o Fund 367 SB2 Planning Grant this is a reimbursable grant. Second round of Reimbursement requests were submitted in February and are still pending. HCD has been backlogged and recently confirmed requests are approved and pending payment. Next reimbursement request scheduled to completed and submitted in September or October depending on project activity.
  - Fund 376 Downtown Streetscape This project is primarily (89%) funded with grant funds on a reimbursement basis. Reimbursement requests expected to be submitted on a quarterly basis. The first request was submitted at end of July and received in August. The balance of funding (11%) will be a City General Fund match.

- Fund 378 Zoning Code Update. This project is 100% funded with grant funds on a reimbursement basis. Reimbursement requests expected to be submitted on a quarterly basis. The first request was submitted in August.
- o Fund 575 WWTP Construction Grant. This is a reimbursable grant. Reimbursement requests are scheduled to be submitted quarterly final grant award was processed in December. The first reimbursement request was submitted in early March 2022 and received in May 2022. Second reimbursement request was submitted in August and is pending approval.
- Fund 576 Phase II Pond 3 Fissure Repair. This project is being funded by insurance. Final Project costs were submitted for reimbursement in early March 2022 65% of costs were reimbursed in May with the balance now expected in late August or September.
- Anticipated revenues/expenditures for July include:
  - o Revenues
    - Allocation for Sales Tax revenues reported/paid to the State for the month of July 2022 (two-month lag).
  - Expenditures
    - Ongoing monthly operating expenses.
    - Approved capital project expenditures expect an increase as WWTP solar project and Lift Station #5 repair projects have expected increased activity.

**RECOMMENDED ACTION:** Waive the second reading, conduct a public hearing and adopt Ordinance 550 authorizing restricting or prohibiting parking on narrow streets, to be effective 30 days after adoption.

### Summary/Background

The proposed ordinance, if adopted, will authorize the City Engineer, with prior City Council approval, to prohibit parking on streets when the width of the roadway does not exceed 20 feet, and to prohibit parking on one side of a street when the width of the roadway does not exceed 30 feet. All narrow streets upon which parking is restricted or prohibited will be designated by official signs or markings.

This ordinance was introduced at the August 24, 2022, meeting, at which Council waived the first reading and scheduled the second reading, public hearing, and adoption for this meeting. There have been no changes to the language of the draft ordinance since August 24. The balance of this staff report substantially reiterates the August 22, 2022, staff report.

This issue was initially discussed at the June 8, 2022, regular City Council meeting. Staff was directed to propose language that can be added to Colfax Municipal Code ("CMC") Chapter 10.16 to allow the City Engineer, with prior Council approval, to post signs restricting or prohibiting parking on narrow streets within City limits, and to consider whether an amendment to CMC Chapter 10.16 is needed to accomplish that result. On August 10, 2022, Council directed staff to bring forward an ordinance to that effect for consideration by Council and the public.

The language presented at the August 10 was slightly modified for discussion on August 24. The draft submitted on August 24 was not subsequently changed and still reads as follows:

"The City Engineer, with prior approval of the City Council, is hereby authorized to place signs or markings indicating restricted or no parking upon any street when the width of the roadway does not exceed 20 feet, or upon one side of a street as indicated by such signs or markings when the width of the roadway does not exceed 30 feet. When official signs or markings restricting or prohibiting parking are erected upon narrow streets as authorized in this section, no persons shall park a vehicle upon any such street in violation of any such sign or marking."

Allowing restricted parking as opposed to no parking at all will permit the City Engineer to consider creative ways to regulate parking on narrow streets without prohibiting it altogether.

If this ordinance is adopted as drafted, the City Engineer will not have authority to restrict or prohibit parking on any narrow street until approval is given by the City Council. It is anticipated that the City Engineer will

make recommendations to the City Council for consideration at a public meeting, that members of the public will be allowed to comment on the City Engineer's recommendations, and that signs restricting or prohibiting parking on narrow streets will not be erected unless and until the Council approves doing so.

The Colfax Municipal Code vaguely addresses regulation of parking in CMC Section 10.16.040: "The city may designate areas for diagonal, parallel, right angle, limited or prohibited parking. The director of public works shall erect signs and mark those portions of the streets and curbs designated for such parking."

This general authorization is likely not sufficient to restrict or prohibit parking on narrow streets. CMC Section 10.16.080 on its face defines the areas within the City in which parking is prohibited. That section does not allow parking on narrow streets to be restricted or prohibited. Other portions of CMC Chapter 10.16 address specific types of parking the Council wanted to restrict or prohibit, none of which include parking on narrow streets. There is at best an ambiguity in the City's existing regulatory authority, and at worst a lack of authority to regulate parking on narrow streets without amending the CMC.

The Placer County Sheriff's Office is responsible for parking enforcement. See CMC 10.16.030. PCSO has indicated that if Colfax wants to restrict or prohibit parking on certain residential streets, it will need to adopt an enforceable ordinance to that effect and post appropriate signage.

The Sheriff has received one complaint that vehicles parked along a narrow street prohibit safe passage by emergency, utility, and sanitation vehicles. Various members of the City Council and members of City staff have either received or are aware of multiple complaints to the same effect. Recology has apparently been unable to access one or more streets for refuse collection.

The language of this draft ordinance is simple, but the effect can be profound. There are many streets within City limits that fall within the roadway widths that will be subject to restriction or prohibition if this ordinance is adopted. Ideally, cooperation between neighbors residing on narrow streets should minimize the need for formal restriction, prohibition, and enforcement. Where neighborhood cooperation is not adequate, however, Council will have to decide whether to impose and enforce the authority this ordinance provides for.

Staff will be available to answer questions or provide additional information.

### **Fiscal Impacts**

Posting and maintaining the necessary signage will involve the expenditure of city funds. There will also be some level of enforcement cost.

# AN ORDINANCE OF THE CITY OF COLFAX AMENDING COLFAX MUNICIPAL TITLE 10, CHAPTER 10.16 BY ADDING SUBSECTION 10.16.080 C TO AUTHORIZE RESTRICTING OR PROHIBITING PARKING ON NARROW STREETS

The City Council of the City of Colfax does ordain as follows:

### Section 1:

Colfax Municipal Code Title 10, Chapter 10.16, Section 10.16.080 is hereby amended by adding Subsection 10.16.080 C in the form and substance contained in the Ordinance attached hereto as Exhibit A and incorporated herein by this reference.

### Section 2. Superceding Provisions

The provisions of this Ordinance and any resolution adopted pursuant hereto shall supersede and repeal any previous Ordinance or resolution to the extent the same is in conflict herewith.

### Section 3. Severability

If any section, phrase, sentence, or portion of this Ordinance is for any reason held invalid or unconstitutional by the final judgment of any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision; and such holding shall not affect the validity of the remaining portions hereof.

### Section 4. California Environmental Quality Act Findings

The City of Colfax finds that, if the provisions of the California Environmental Quality Act, Public Resources Code §21000 et seq (hereinafter "CEQA") apply, the title of this ordinance would constitute a brief description of the "Project" as required by Section 15062(a)(1) of the Guidelines for Implementation of the California Environmental Quality Act published by the State of California Office of Planning and Research (the "CEQA Guidelines").

#### FINDING OF NO PROJECT

The City of Colfax finds that adoption of this ordinance does not constitute a "Project" as that term is defined by or used in CEQA, the CEQA Guidelines or any court or attorney general opinion construing the same. Accordingly, the City of Colfax finds that the provisions of CEQA and the CEQA Guidelines are not applicable to said action.

### FINDING OF EXEMPTION

In the event that it is found that the said action constitutes a "Project" as defined by or used in CEQA or the CEQA Guidelines, which finding would be contrary to the City's opinion of its action, the City of Colfax hereby finds that said action is exempt from compliance with CEQA and the CEQA Guidelines, for the following reasons: The action falls within the exemptions provided by Senate Bill 94, and within the "common sense" CEQA exemption provided in 14

CCR 15061(b)(3) in that CEQA applies only to projects which have the potential for causing a significant effect on the environment. Where it can be seen with certainty that there is no possibility that the action may have a significant effect on the environment, the action is not subject to CEQA. CEQA Guidelines, Section 15061(b)(3). It can be seen with certainty that adoption of this ordinance and its provisions cannot possibly have a significant effect on the environment.

### Section 5. Effective Date

This Ordinance, and all of its provisions, shall take effect thirty (30) days after its adoption and shall, within 15 days after its adoption, be published or posted in accordance with Section 36933 of the Government Code of the State of California with the names of those City Council members voting for and against it.



When official signs or markings restricting or prohibiting parking are erected upon narrow streets as authorized in this section, no persons shall park a vehicle upon any such street in violation of any such sign or marking."
- **Section 2.** The remainder of Colfax Municipal Code Title 10, Chapter 10.16 shall remain in full force and effect. If any of the provisions of Colfax Municipal Code Chapter 10.16 are inconsistent with the provisions of this Ordinance, then this Ordinance and the provisions hereof shall control any inconsistent interpretation.

**RECOMMENDED ACTION:** Adopt Resolution \_\_-2022 authorizing the City Manager to execute a Second Amendment to the December 17, 2021, Subdivision Improvement Agreement with Colfax Hospitality Partners, LLC, for the Best Western Hotel Project.

### Summary/Background

The proposed resolution, if adopted, will extend by 60 days, until November 16, 2022, the Owner's obligation to complete all public and private improvements for the Best Western Hotel, and will continue to require adequate security for completion of those improvements. The basis of the Owner's request for this additional 60-day extension is that supply chain issues have delayed delivery of some of the supplies and materials needed to complete the Project Improvements.

On June 13, 2018, the City Council adopted Resolution 43-2018 whereby it approved a mitigated negative declaration and design review DRP-2017-03 for the Best Western Hotel on South Auburn Street in the City (the "Project"). The conditions of Project approval impose upon the project Owner the obligation to install several project improvements prior to obtaining a certificate of occupancy.

On December 17, 2021, upon request by the Owner and with the recommendation of City staff, the Council authorized execution of a Subdivision Improvement Agreement that allowed the Owner to receive a certificate of project occupancy before completing all required Project improvements. The Subdivision Improvement Agreement obliged the Owner to deposit \$113,920.00 as security for completion of the Project improvements and required the improvements to be completed no later than June 17, 2022. The Owner timely deposited the required security, which the City continues to hold.

On June 8, 2022, at the Owner's request, the City Council adopted Resolution 17-2022 whereby it authorized the City Manager to execute the First Amendment to the Subdivision Improvement Agreement (the "First Amendment"). The First Amendment extended by three months, until September 17, 2022, the Owner's obligation to complete all Project Improvements and continued to require adequate security to complete them.

Circumstances have changed such that Owner will not be able to complete all Project improvements by September 17, 2022. Supply chain issues have delayed delivery of some of the supplies and materials needed to complete the Project improvements. These changed circumstances prompted the Owner to request, and staff to recommend, a 60-day extension of the September 17, 2022, deadline to November 16, 2022. The City will continue to require adequate security for all improvements.

Staff recommends that Council adopt the proposed resolution authorizing the City Manager to execute the Second Amendment to the Subdivision Improvement Agreement with Colfax Hospitality Partners, LLC.

WHEREAS, on June 13, 2018, the City Council adopted its Resolution 43-2018 whereby it approved a mitigated negative declaration and design review DRP-2017-03 for a Best Western Hotel on South Auburn Street in the City (the "Project"); and,

**WHEREAS**, the conditions of Project approval require the Project developer and owner, Colfax Hospitality Partners, LLC, to install various public and private Project improvements prior to issuance of a Project certificate of occupancy; and,

WHEREAS, on December 17, 2021, the City Council authorized the City Manager to execute a Subdivision Improvement Agreement (the "Subdivision Improvement Agreement") that allowed the City to issue a certificate of occupancy for the Best Western Hotel in exchange for the Hotel Owner's agreement to complete all project improvements no later than June 17, 2022, and the Owner's deposit of a valid check in the amount of \$113,920.00 to secure completion of the Project improvements; and

WHEREAS, On June 8, 2022, at the Owner's request, the City Council adopted Resolution 17-2022 whereby it authorized the City Manager to execute the First Amendment to the Subdivision Improvement Agreement (the "First Amendment"). The First Amendment extended by three months, until September 17, 2022, the Owner's obligation to complete all Project Improvements and continued to require adequate security to complete them.

WHEREAS, circumstances have changed such that Owner will not be able to complete all Project Improvements by September 17, 2022, and has requested, and City staff has recommended, a sixty-day extension to November 16, 2022, to complete all required project improvements; and,

**WHEREAS**, the City Council finds and determines that execution of a second amendment to the Subdivision Improvement Agreement in the form presented to Council and the deposit of security in the form and amount required by that amendment will adequately protect the City and is in the City's best interests.

**NOW THEREFORE, BE IT RESOLVED** that the City Council of the City of Colfax authorizes the City Manager to execute in the name of the City a Second Amendment To Subdivision Improvement Agreement with Colfax Hospitality Partners, LLC, in the form presented to Council for approval and attached to this Resolution.

### SECOND AMENDMENT TO CITY OF COLFAX SUBDIVISION IMPROVEMENT AGREEMENT FOR THE BEST WESTERN HOTEL PROJECT

This Second Amendment to Subdivision Improvement Agreement for the Best Western Hotel Project ("Second Amendment") is made and entered by and among the City of Colfax, a Municipal Corporation of the State of California, and General Law City ("City"), and Colfax Hospitality Partners, LLC, a California Limited Liability Company ("Owner"). The City and Owner may be referred to herein individually as a "Party" and collectively as the "Parties".

### **RECITALS**

This Second Amendment is entered on the basis of the following facts, understandings and intentions of the Parties:

- A. On June 13, 2018, the City Council adopted Resolution 43-2018 whereby it approved a mitigated negative declaration and design review DRP-2017-03 for a Best Western Hotel on South Auburn Street in the City (the "Project").
- B. The conditions of Project approval (the "Project Approvals") impose upon the Owner a requirement that improvements installed by the Owner for the benefit of the Project shall contain supplemental size, capacity, number, or length for the benefit of property not within the development (the "Road Improvements") and that the Road Improvements be dedicated to the public. The required project improvements include (a) the Road Improvements, (b) the items listed in a letter dated December 10, 2021, from Carl Moore, Contract City Engineer to Owner, and (c) completion of a screen wall/fence along the Project property line. For purposes of this Second Amendment, all public and private improvements required by the Project Approvals will be referred to collectively as the "Project Improvements".
- C. The Project Conditions of Approval require the Owner to either construct all public and private Project Improvements to the satisfaction of the City or enter into a subdivision improvement agreement for completion of all public and private improvements prior to occupancy of the Project and provide bonds, proof of workers compensation insurance and general liability insurance in forms and amounts deemed satisfactory to and by the City.
- D. Colfax Municipal Code ("CMC") Section 16.48.30 requires the Owner to provide various forms and amounts of security for completion of Project Improvements. CMC Section 16.48.030 D requires security in sufficient amount deemed necessary by the City to assure faithful performance of the Project Improvements in the event of default or, in the case of a subdivision, where a final map is not prepared and approved. Such security must be in a form acceptable to the City and be in the amount of one-hundred ten percent (110%) of the cost of the Project Improvements for Performance and fifty percent (50%) of the cost of the Project Improvements for Labor and Materials.
- E. As of December 17, 2021, the City and Owner estimated that the cost for completing the Project Improvements, which is the basis upon which the amount of all bonding or other security was required, was \$113,920.00, subject to adjustment as determined by the City.
- F. On December 17, 2021, the Colfax City Council authorized, and the Parties executed, a Subdivision Improvement Agreement for the Best Western Hotel Project (the "Subdivision Improvement Agreement") that required, among other things, the Owner to complete all Project Improvements no later

than June 17, 2022, and to post security in the amount of \$113,920.00 (the "Security Deposit"). The Owner timely posted its check in the amount of \$113,920.00 as and for the Security Deposit, which the City continues to hold.

- G. In accordance with the Subdivision Improvement Agreement, the City issued Owner a certificate of occupancy for the Project on December 17, 2021.
- H. On June 8, 2022, at the Owner's request, the City Council adopted Resolution 17-2022 whereby it authorized the City Manager to execute the First Amendment to the Subdivision Improvement Agreement (the "First Amendment"). The First Amendment extended by three months, until September 17, 2022, the Owner's obligation to complete all Project Improvements and continued to require adequate security to complete them.
- I. Circumstances have changed since the First Amendment was executed, such that Owner will not be able to complete all Project Improvements by September 17, 2022. In particular, supply chain issues have delayed delivery of some of the supplies and materials needed to complete the Project Improvements. These changed circumstances prompted the Owner to request a second 60-day extension of the deadline for completing the Project Improvements. These changed circumstances and others warrant modification of the deadlines established in, and other provisions of, the First Amendment.
- J. The Parties desire to again amend the Subdivision Improvement Agreement to (a) extend the deadline for completing the Project Improvements either as approved or as subsequently modified, to the City's satisfaction, and (b) to ensure that adequate security for the Project Improvements remains in place.

### **AGREEMENT**

NOW THEREFORE, in consideration of the mutual covenants contained in this Second Amendment, the City and Owner agree as follows:

### **Section 1: Incorporation of Recitals.**

1.1 The foregoing Recitals are true and correct statements of fact and are incorporated into this Second Amendment by this reference.

### **Section 2: Effective Date and Term.**

- 2.1 Effective Date. This Second Amendment shall be dated, and the obligations of the City and the Owner shall be effective as of the date upon which this Second Amendment is executed by the City (the "Effective Date").
- 2.2 Term. The Term of this Second Amendment shall commence on the Effective Date and shall expire on the earlier of November 16, 2022, or when all Project Improvements are completed to the City's satisfaction.

### **Section 3: Project Improvements.**

3.1 The Parties acknowledge that the Owner timely posted the \$113,920.00 Security Deposit required by the Subdivision Improvement Agreement. The City shall continue to hold the Security Deposit until all Project Improvements as originally approved or as subsequently modified and approved by the City are completed to the City's satisfaction. If the Owner fails to complete all Project Improvements to the

City's satisfaction by November 16, 2022, the City may, in its sole discretion, apply the Security Deposit toward the cost of completing the Project Improvements in accordance with Colfax Municipal Code Chapter 16.48. If the Owner completes the Project Improvements to the City's satisfaction by November 16, 2022, the Security Deposit, or so much thereof that has not been applied to completion of the Project Improvements, will be released to the Owner in accordance with Colfax Municipal Code Chapter 16.48.


3.2 The City may require the Owner to replace the Security Deposit. If the City requires replacement of the Security Deposit, the Owner shall replace the Security Deposit with equal security, or such greater or lesser amount as the City may require any time prior to the completion of the Project Improvements.

### Section 4. Subdivision Improvement Agreement Otherwise Unmodified.

4.1 The remainder of the Subdivision Improvement Agreement and First Amendment shall remain in full force and effect. All provisions of the Subdivision Improvement Agreement and First Amendment are applicable to and incorporated into this Second Amendment, except to the extent that such provisions are inconsistent herewith. If any term, condition, or provision of the Subdivision Improvement Agreement or First Amendment is inconsistent with the provisions of this Second Amendment, then the provisions of this Second Amendment shall control to the extent necessary to resolve or interpret any such inconsistency.

The following is a punch list notice of road improvements and onsite improvements that require corrections:

#### Road Improvement Items Identified

- The landscape area between the sidewalk and curb & gutter along S. Auburn where the swale was filled in and a culvert placed prior to the city receiving any revised plans will require treatment. Acceptable treatment includes removal of all vegetation (including invasive species) from the swale, installing a weed barrier and reinstalling riprap to secure the inorganic mulch layer. The amount of reinstalled of riprap should be 2-3 times greater than what was originally installed.
- Remove garbage within the city right-of-way

List of onsite improvements previously identified that still require correction:

- 1. Per previous conversations at City Hall, the revised plan dated 9/10/2021 will be voided and construction will proceed along the access road per approval plans. The following items are outstanding and/or require an updated plan revision:
  - a) Access road off Whitcomb Ave requires paving.
  - b) AC curb to be added on both sides of the access road as a plan revision.
  - c) Complete the screen wall along the fire access road per plan. On the adjacent property owner side, add compacted dirt or aggregate base from the top of footing to form a smooth transition to existing grade. Install a fence on top of the 3' high CMU wall.
  - d) Provide a detail for the 4-block high screen wall including a fence to be installed on top of the screen wall to meet the code requirement of 4-6foot high screen wall as a plan revision.
  - e) Install on 18' x 18' drainage inlet on the adjacent property where the storm drain was intercepted and connect into existing storm drainpipe with 12" SD pipe as a plan revision. Though this was completed, the City will still need to receive inspection documents certifying that the pipe was installed to industry standards.
- 2. Hole in access road due to drainage needs to be excavated to repair pipe and backfill with competent material in the presence of the site geotechnical engineer and City Inspector.
- 3. Provide an appropriate cap to all screen walls per plan.
