Summary/Background

CITY OF

The proposed Resolution, if adopted, will authorize the City Council to conduct its meetings virtually or in person under the teleconference rules contained in Government Code Section 54953(e).

On March 4, 2020, the Governor proclaimed a state of emergency to address the threat of the COVID-19 pandemic. That proclamation remains in effect.

On March 17, 2020, Governor Newsom signed Executive Order N-29-20 which allowed Council to meet virtually under relaxed teleconferencing rules. Council did so until Executive Order N-29-20 expired on September 30, 2021, and was replaced by different rules under Government Code Section 54953(e) [AB 361] effective October 1, 2021. Council initially elected to resume meeting in person, but the persistence of the COVID pandemic has prompted Council and staff to consider resuming its virtual meetings.

Government Code Section 54953(e) authorizes Council to use teleconferencing to hold its meetings during a proclaimed state of emergency when state or local officials have imposed or recommended measures to promote social distancing. "State of Emergency" is narrowly defined such that one only exists when the Governor has proclaimed one under the authority of Government Code Section 8625, which occurred on March 4, 2020, and remains in effect.

If Council adopts the recommended Resolution, meetings must meet the following requirements:

1. Agendas and notice of the meeting must be posted, but not at all teleconference locations. (GC 54953(e)(2)(A)).

2. Members of the public must be allowed to access the meeting and address the Council. The agenda must (1) include notice of the means by which members of the public can access the meeting and comment, and (2) identify and include an opportunity for all persons to attend via call-in option or internet-based service option, but the City is not required to provide a physical location from which the public may attend or comment. (GC 54953(e)(2)(B)).

3. Teleconference meetings must protect the statutory and constitutional rights of all parties and members of the public appearing before Council. (GC 54953(e)(2)(C)).

4. If a disruption occurs that prevents the city from broadcasting the meeting or that prevents the public from participating or commenting using the call-in option, no further action on the agenda items can be taken until the disruption is remedied. (GC 54953(e)(2)(D)).

5. The City cannot require public comments to be submitted in advance of the meeting and must allow for comments to be made in "real time". This does not require the city to provide a physical location from which the public may attend or comment. (GC 54953(e)(2)(E)).

6. GC Section 54953.3 precludes the City from requiring meeting attendees to register his or her name or to provide other information, complete a questionnaire, or fulfill any other condition precedent to attendance. AB 361 provides that individuals who want to provide public comment through the use of an internet website or other online platform not under the City's control may nevertheless be required to register as required by that third-party internet website or online platform to participate. (GC 54953(e)(2)(F)).

7. Colfax takes public comment separately on each agenda item so it will have to allow a reasonable amount of time per agenda item for the public to register or be recognized for the purpose of providing public comment. (GC 54953(e)(2)(G)(ii)). This generally applies to the public comment period on matters within the City's subject matter jurisdiction.

8. The following findings must be made within 30 days after teleconferencing under AB 361 for the first time without complying with Government Code Section 54953(b)(3) and every 30 days thereafter: (A) The Council has reconsidered the circumstances of the state of emergency, (B) Either the state of emergency continues to directly impact the ability of the Council to meet safely in person, or state or local officials continue to impose or recommend measures to promote social distancing. (GC 54953(e)(3)). Staff plans to place this periodic review on the Consent Calendar.

Staff is prepared to implement these requirements and will be available to answer any questions.

AUTHORIZING REMOTE TELECONFERENCE MEETINGS PURSUANT TO GOVERNMENT CODE SECTION 54953(e) [AB 361]

WHEREAS, Government Code Section 54953(e), as adopted by Assembly Bill 361 (AB 361) allows the Council to hold open meetings by teleconference without reference to otherwise applicable requirements of Government Code Section 54953(b)(3), so long as Council complies with legally-imposed requirements, there exists a declared state of emergency, and one of the following circumstances is met: (1) State or local officials have imposed or recommended measures to promote social distancing, (2) Council is holding the meeting for the purpose of determining, by majority vote, whether as a result of the emergency, meeting in person would present imminent risks to the health and safety of attendees, and (3) Council has determined, by majority vote, that as a result of the emergency, meeting in person would present imminent risks to the health and safety of attendees, and (3) Council has determined, by majority vote, that as a result of the emergency, meeting in person would present imminent risks to the health and safety of attendees, and (3) Council has determined, by majority vote, that as a result of the emergency, meeting in person would present imminent risks to the health and safety of attendees; and,

WHEREAS, on March 4, 2020, the Governor proclaimed a state of emergency pursuant to Government Code Section 8625, and that proclamation remains in effect; and,

WHEREAS, the City Council, having reconsidered the circumstances of the state of emergency, hereby declares that a state of emergency as a result of the threat of COVID-19 still exists and continues to impact the ability of members of the public, the City Council, Council subcommittees, City staff and consultants to meet safely in person.

NOW THEREFORE, BE IT RESOLVED BY the City Council of the City of Colfax as follows:

1. The foregoing recitals are true and correct statements of fact and are incorporated into this Resolution by this reference.

2. The City Council hereby finds and declares the following conditions are met as required by Government Code Section 54953(e)(3):

(i) The Governor of California proclaimed a state of emergency on March 4, 2020, pursuant to Government Code Section 8625, which remains in effect.

(ii) The City Council has determined that, as a result of the emergency, meeting in person would present imminent risks to the health and safety of attendees.

3. The City Manager is authorized to utilize teleconferencing to conduct all City of Colfax public meetings pursuant to AB 361 and Government Code Section 54953(e).

4. In accordance with AB 361, the City Council shall reconsider the passage of this Resolution not less than every 30 days to determine whether a state of emergency continues to directly impact the ability of the Council to meet safely in person, or whether state or local officials continue to impose or recommend social distancing, until this Resolution is rescinded.

Summary/Background

CITY OF

The proposed resolution, if adopted, will extend until December 31, 2022, the Owner's obligation to complete all public and private improvements for the Maidu ARCO project, and will continue to require adequate security for completion of those improvements.

On December 12, 2018, the City Council adopted its Resolution 76-2018 whereby it approved a Mitigated Negative Declaration, Vesting Tentative Parcel Map, Master Site Plan and Planned Development Permit for the Maidu Development Project (the "Maidu Development Project") and Resolution 77-2018 approving the design review permit for an ARCO Service Station at the Maidu Village Development Project in the City (the "ARCO Project"). The conditions of Project approval impose upon the project Owner the obligation to install several project improvements prior to obtaining a certificate of occupancy.

On August 31, 2022, upon request by the Owner and with the recommendation of City staff, the Council authorized execution of a Subdivision Improvement Agreement that allowed the Owner to receive a certificate of ARCO Project occupancy before completing all required ARCO Project improvements. The Subdivision Improvement Agreement obliged the Owner to deposit \$36,500.00 as security for completion of the Project improvements and required the improvements to be completed no later than October 31, 2022. The Owner timely deposited the required security, which the City continues to hold.

Circumstances have changed since August 31, 2022, such that Owner will not be able to complete all Project Improvements by October 31, 2022. These changed circumstances prompted the Owner to request, and staff to recommend, an extension of the October 31, 2022, deadline to December 31, 2022. The City will continue to require adequate security for all improvements. Outstanding project items that require completion are as follows:

- Complete access road to Mountain Village.
- Remove concrete rubble pile down to first layer.
- Install landscaping per plan along S. Auburn street frontage of Lot 2, match planting and irrigation near roundabout street frontage.
- Complete backfill behind frontage retaining wall by controller.
- Stabilize disturbed areas prior to forecasted rain events, install BMP's to protect Lots 1-3.
- Cover soil stockpiles prior to forecast rain events.

- Compact slope parallel to McDonald's parcel.
- Repair torn gasket on sewer line connection at the front of the store.

Staff recommends that Council adopt the proposed resolution authorizing the City Manager to execute the First Amendment to the Subdivision Improvement Agreement with Colfax Auburn, LLC.

FIRST AMENDMENT TO CITY OF COLFAX SUBDIVISION IMPROVEMENT AGREEMENT FOR THE MAIDU VILLAGE ARCO PROJECT

This First Amendment to Subdivision Improvement Agreement for the Maidu Village Arco Project ("First Amendment") is made and entered by and among the City of Colfax, a Municipal Corporation of the State of California, and General Law City ("City"), and Colfax Auburn, LLC, a California Limited Liability Company ("Owner"). The City and Owner may be referred to herein individually as a "Party" and collectively as the "Parties".

RECITALS

This First Amendment is entered on the basis of the following facts, understandings and intentions of the Parties:

A. On December 12, 2018, the City Council adopted its Resolution 76-2018 approving a Mitigated Negative Declaration, Vesting Tentative Parcel Map, Master Site Plan and Planned Development Permit for the Maidu Village Development Project (the "Maidu Development Project) and Resolution 77-2018 approving the design review permit for an ARCO Service Station at the Maidu Village Development Project in the City (the "ARCO Project").

B. The conditions of approval for the Maidu Development Project and ARCO Project impose upon the Owner a requirement for installation of certain public and private improvements at Owner expense. For purposes of this Agreement, all public and private improvements required by the Project Approvals will be referred to collectively as the "Project Improvements".

C. The Maidu Development Project and ARCO Project Conditions of Approval require the Owner to either construct all public and private Project Improvements to the satisfaction of the City or enter into a subdivision improvement agreement for completion of all public and private improvements prior to issuance of a certificate of occupancy by the City for either Project and provide bonds, proof of workers compensation insurance and general liability insurance in forms and amounts as deemed satisfactory to the City.

D Colfax Municipal Code ("CMC") Section 16.48.30 requires the Owner to provide various forms and amounts of security for completion of Project Improvements. CMC Section 16.48.030 D requires security in sufficient amount deemed necessary by the City to assure faithful performance of the Project Improvements in the event of default or, in the case of a subdivision, where a final map is not prepared and approved. The City and Owner estimate that the cost for completing the Project Improvements required to be completed under this Agreement, which is the basis upon which the amount of all bonding or other security will be required, is \$36,500.00. This estimate, and the final basis upon which all required bonding or other security will be established, may be adjusted by the City.

E. The City has found that this Agreement is in accordance with applicable provisions of the Colfax Municipal Code and California Law and is in the City's best interests.

F. Effective August 31, 2022, the Colfax City Council authorized, and the Parties executed, a Subdivision Improvement Agreement for the Maidu Village Arco Project (the "Subdivision Improvement Agreement") that required, among other things, the Owner to complete all Project Improvements no later than October 31, 2022, and to post security in the amount of \$36,500.00 (the "Security Deposit"). The Owner timely posted its check in the amount of \$36,500.00 as and for the Security Deposit, which the City continues to hold.

G. In accordance with the Subdivision Improvement Agreement, the City issued Owner a certificate of occupancy for the Project on August 31, 2022.

I. Circumstances have changed since the Subdivision Improvement Agreement was executed, such that Owner will not be able to complete all Project Improvements by October 31, 2022. These changed circumstances prompted the Owner to request an of the deadline for completing the Project Improvements. These changed circumstances and others warrant modification of the deadlines established in, and other provisions of, the Subdivision Improvement Agreement.

J. The Parties desire to amend the Subdivision Improvement Agreement to (a) extend the deadline for completing the Project Improvements either as approved or as subsequently modified, to the City's satisfaction, and (b) to ensure that adequate security for the Project Improvements remains in place.

AGREEMENT

NOW THEREFORE, in consideration of the mutual covenants contained in this First Amendment, the City and Owner agree as follows:

Section 1: Incorporation of Recitals.

1.1 The foregoing Recitals are true and correct statements of fact and are incorporated into this First Amendment by this reference.

Section 2: Effective Date and Term.

2.1 Effective Date. This First Amendment shall be dated, and the obligations of the City and the Owner shall be effective as of the date upon which this First Amendment is executed by the City (the "Effective Date").

2.2 Term. The Term of this First Amendment shall commence on the Effective Date and shall expire on the earlier of December 31, 2022, or when all Project Improvements are completed to the City's satisfaction.

Section 3: Project Improvements.

3.1 The Parties acknowledge that the Owner timely posted the \$36,500.00 Security Deposit required by the Subdivision Improvement Agreement. The City shall continue to hold the Security Deposit until all Project Improvements as originally approved or as subsequently modified and approved by the City are completed to the City's satisfaction. If the Owner fails to complete all Project Improvements to the City's satisfaction by December 31, 2022, the City may, in its sole discretion, apply the Security Deposit toward the cost of completing the Project Improvements in accordance with Colfax Municipal Code Chapter 16.48. If the Owner completes the Project Improvements to the City's satisfaction by December 31, 2022, the Security Deposit, or so much thereof that has not been applied to completion of the Project Improvements, will be released to the Owner in accordance with Colfax Municipal Code Chapter 16.48.

3.2 The City may require the Owner to replace the Security Deposit. If the City requires replacement of the Security Deposit, the Owner shall replace the Security Deposit with equal security, or such greater or lesser amount as the City may require any time prior to the completion of the Project Improvements.

Section 4. Subdivision Improvement Agreement Otherwise Unmodified.

4.1 The remainder of the Subdivision Improvement Agreement shall remain in full force and effect. All provisions of the Subdivision Improvement Agreement are applicable to and incorporated into this First Amendment, except to the extent that such provisions are inconsistent herewith. If any term, condition, or provision of the Subdivision Improvement Agreement is inconsistent with the provisions of this First Amendment, then the provisions of this First Amendment shall control to the extent necessary to resolve or interpret any such inconsistency.

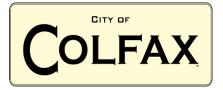

RECOMMENDED ACTION: Adopt Resolution _____-2022 authorizing the Mayor and City Manager to sign a Side Letter Agreement modifying the Compensatory Time Off provisions in the Memorandum of Understanding with Stationary Engineers, Local 39.

Summary/Background

The proposed resolution, if adopted, will allow members of Stationary Engineers, Local 39, and other City employees to decide whether to take overtime in the form of compensatory time off or payroll compensation. Eligible employees will be allowed to make that decision in December of each year, effective for the ensuing year. Once made, the decision will be irrevocable until the following December. This change was requested by Local 39.

The existing memorandum of understanding (MOU) between the City and Local 39 is effective from July 1, 2021, through June 30, 2026. Effective July 1, 2021, maximum compensatory time off (CTO) accrual was reduced from 80 hours per year to 60 hours per year. The MOU allows the City Manager to approve an employee's request to cash out the employee's accrued CTO. The proposed change will allow employees to elect to receive overtime as either CTO or payroll compensation without City Manager approval.

Some employees have accrued CTO above the 60-hour cap. The hours above the 60-hour cap are considered "frozen" with no additional hours accruing until the accrued hours fall below 60. An effort will be made to reduce those "frozen" hours by scheduling time off, but employees may also elect payroll compensation in exchange for accrued "frozen" hours.

Staff recommends that the Council adopt the proposed resolution and will be available to answer questions or provide additional information.

Fiscal Impacts

Adopting the proposed resolution may increase payroll expenses but may also reduce the amount of CTO utilized by City employees.

Side Letter Agreement to City of Colfax Memorandum of Understanding With Stationary Engineers, Local 39 2021 – 2026

This Side Letter Agreement amends the current Memorandum of Understanding between the parties. Article 7 C – Compensatory Time Off – will now read as follows:

C. <u>Compensatory Time Off.</u> The City may compensate for overtime by providing Compensatory Time Off (CTO) at the rate of time and one-half. Effective July 1, 2021, CTO accrual will be capped at 60 hours. All future accrued CTO over the new 60 -hour cap will be paid out as overtime pay. Existing accrued CTO hours over the new 60-hour cap will be "frozen" with no further hours accruing. In December of each year, effective for the following calendar year, employees may elect to take overtime in the form of CTO or payroll compensation. Once made, this election is irrevocable until the following December. However, employees who elect to receive CTO and have 60 hours of accrued time shall receive payroll compensation until such time as their CTO hours are below 60. Payroll compensation that is requested by December 15th in exchange for accrued CTO hours will be paid out not later than the second pay period in January. Newly accrued hours will be accrued separately subject to the 60-hour cap. An effort is to be made to reduce the "frozen" hours by scheduling time off with the employee's supervisor. CTO leave shall require a minimum of 3 workdays advance notice.

This Side Letter Agreement does not modify any other section of the Memorandum of Understanding which remains in full force and effect.

BACKGROUND

PCTPA's Regional Transportation Plan and SACOG's 2024 Blueprint (Metropolitan **Transportation Plan/Sustainable Communities Strategy**)

As the State-designated Regional Transportation Planning Agency (RTPA) for Placer County, the Placer County Transportation Planning Agency (PCTPA) is required to prepare and adopt a Regional Transportation Plan (RTP) every five years. The RTP is a long range (20-year minimum), transportation funding plan that identifies the priorities for addressing existing and future traffic congestion on, mobility needs for, and maintenance of the transportation infrastructure, programs, and services located in the incorporated cities of Roseville, Rocklin, Lincoln, Auburn, and Colfax, the town of Loomis, and unincorporated areas of Placer County (excluding the Lake Tahoe basin). Not only does the RTP comply with state statutes for continuous, cooperative, and comprehensive planning, it also provides the mechanism by which state and federal funds are allocated to local transportation projects. PCTPA's current RTP was adopted in December 2019, and contains the Placer region's financially-constrained transportation investments (projects list) planned for delivery through 2040.

The Placer County RTP is integrated into the broader regional planning context of the Sacramento Area Council of Governments' (SACOG) Metropolitan Transportation Plan (MTP) and Sustainable Communities Strategy (SCS). SACOG is the state designated RTPA for Sacramento, Sutter, Yolo, and Yuba counties and also serves as the federally designated Metropolitan Planning Organization (MPO) for the six-county region, which includes Placer and El Dorado counties. As an RTPA and MPO, SACOG updates the MTP/SCS (known as the Blueprint in this update cycle) every four years to satisfy its federal planning responsibilities for the six-county region and to address state greenhouse gas emissions reduction requirements for the SCS pursuant to Senate Bill 375 (SB 375). PCTPA has a Memorandum of Understanding (MOU) with SACOG to provide demographic growth projections, financial forecasting assistance, and air quality modeling services that support PCTPA's planning efforts, including those for the RTP. For these reasons, the financially constrained transportation project lists produced in both Placer County's RTP and SACOG's MTP/SCS (for the Placer County region) are the same. However, unlike the Placer

County RTP, SACOG's MTP/SCS also considers how planned land-use development, combined with the transportation investments identified in the project lists, comprehensively address greenhouse gas emission reduction targets for the six-county region per SB 375. When completed, SACOG's Blueprint will contain the six-county region's financially constrained transportation investments aligned with a preferred land use growth development scenario to support future planning efforts, program funding development, and project delivery through 2050.

Annual Unmet Transit Needs Assessment

Each year, PCTPA works with the Placer region's transit operators, social service transportation providers, and other public/private stakeholders to identify any transit needs that are currently not being met by existing public transit services. This process, known as the Unmet Transit Needs (UTN) Assessment, is required by the Transportation Development Act (TDA) because of the specific funding that PCTPA annually administers through the TDA, which can be utilized for street and roadway projects only after PCTPA determines that there are no "unmet transit needs" that are "reasonable to meet" within Placer County (excluding the Tahoe Basin).

PCTPA defines an unmet transit need as a request for public transit service that is not already provided by the existing transit system, specifically in an area that is more than a 0.75-mile walking distance of an existing transit stop or service. A request is also considered an unmet transit need if it is for a service that is needed for compliance with the Americans with Disabilities Act (ADA). For a request to be considered reasonable to meet, PCTPA evaluates any new potential transit service implemented to address the unmet transit need based on meeting all the following criteria:

- The new transit service must meet the fare recovery standards established by PCTPA pursuant to the TDA,
- The new service must be paid for by existing transit funding available through the TDA and be a reasonable use of taxpayer funds,
- There must be strong and broad support for the new transit service (not just a request from a few individuals and/or specific stakeholder interest groups), and
- Implementing the new service must be consistent with both the RTP and short-range transit plan applicable for the jurisdiction where the potential unmet transit need is identified.

If an unmet transit need that is reasonable to meet is identified, then TDA funding must be allocated for that new transit service prior to funding being available for street and road purposes. Please note that general operational issues (e.g., improved bus stop amenities, service reliability, modifications to route schedules and/or bus stops along a given route, customer service, etc.) are not considered unmet transit needs. However, any comments pertaining to these issues are provided to the transit operators for their review and consideration to address.

DISCUSSION

2050 Regional Transportation Plan

The next RTP (known as the 2050 RTP or Plan) extends the Placer region's planning horizon for transportation investments to 2050. The 2050 RTP planning effort will re-examine and update the prior RTP's goals and policies as needed, identify specific performance metrics to track the progress of the Plan, and incorporate community input on long standing transportation priorities in Placer County. The Plan will also address any new state and/or federal planning requirements and/or funding sources adopted since 2019. The 2050 RTP consists of three primary elements:

- Policy Element: Identifies the mobility goals, objectives, and policies of the region
- Action Element: Details the projects, programs, and actions to implement the RTP
- Financial Element: Summarizes the cost of implementing the RTP projects, considering fiscal constraints

Completion of the 2050 RTP is currently anticipated to occur by December 2024. Throughout the process, PCTPA staff will be coordinating with the six cities/town, Placer County, and numerous other agencies/organizations to update project lists, conduct public outreach/engagement for, and ultimately craft Placer County's transportation vision for the next 26 years through the 2050 RTP.

As part of the Plan's initial public engagement/outreach effort, PCTPA staff is presenting an overview of the RTP development process, milestones, coordination opportunities, and soliciting public input at Placer's local agencies, which corresponds to similar efforts being conducted by SACOG for their Blueprint development. These efforts are being coordinated due to the integrated nature and function of both the RTP and MTP/SCS processes. Additionally, PCTPA has released a public survey to solicit input on the 2050 RTP's goals, project priorities, and overall direction to assist staff with planning efforts moving forward. Unmet Transit Needs

This year's UTN Assessment process has begun with the launch of a public transit survey on October 1st, which will be available until November 18th. The survey provides an opportunity for the public to identify their potential unmet transit needs. Survey results will be evaluated by PCTPA staff, the region's transit operators, social service transportation providers, and some key public stakeholders to determine if there are any unmet transit needs that are reasonable to meet based on the criteria described earlier. Findings from this evaluation process will be presented in the annual UTN report provided to the PCTPA Board of Directors for review and adoption in February 2023. All members of the public are encouraged to participate in the survey, which can be accessed at www.pctpa.net/utn. 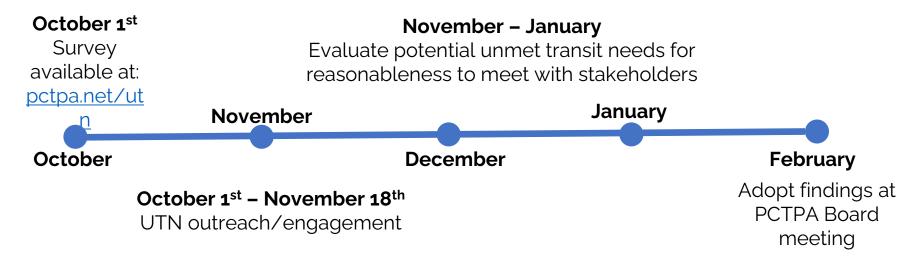
