The work generally consists of but is not limited to the following: new construction of, repair or replacement of 6" thru 15" sewer mains, sewer manholes, and sewer laterals. The method of repair of the sewer main includes replacement by open-cut method, directional drilling, rehabilitated by cured-in-place pipe (CIPP) lining and/or bursting methods. Sewer laterals will be replaced by open-cut methods from the main to the property line including replacement of wye connections. Where none exist, new sewer clean-outs will be installed at the property lines. New water mains will be installed at two sewer rehabilitation sites. The Contractor shall include in their bid and provide all labor, tools and materials for a completed project in conformance with the intent of the drawings and specified herein.

This meeting will be the only time that bidders may access these properties for assessment of the work.

Prospective Bidders shall be licensed Contractors in the State of California and shall be skilled and regularly engaged in the general class or type of work called for under the Contract. Each Bidder shall have a Class A California Contractor's license.

This contract is subject to State contract nondiscrimination and compliance requirements pursuant to Government Code, Section 12990.

Pursuant to Section 1773 of the Labor Code, the general prevailing wage rates in the county, or counties, in which the work is to be done have been determined by the Director of the California Department of Industrial Relations. These wages are set forth in the General Prevailing Wage Rates for this project, available at the City of Colfax City Hall, 33 South Main Street Colfax, CA 95713 and available from the California Department of Industrial Relations' Internet web site at http://www.dir.ca.gov/dlsr/PWD/index.htm. The Federal minimum

wage rates for this project as predetermined by the United States Secretary of Labor are set forth in this specification, copies of this specification may be examined at the offices described above where project plans, special provisions, and bid forms may be seen. Addenda to modify the Federal minimum wage rates, if necessary, will be issued to plan holders. Future effective general prevailing wage rates, which have been predetermined and are on file with the California Department of Industrial Relations are referenced but not printed in the general prevailing wage rates.

Attention is directed to the Federal minimum wage rate requirements in this Specification. If there is a difference between the minimum wage rates predetermined by the Secretary of Labor and the general prevailing wage rates determined by the Director of the California Department of Industrial Relations for similar classifications of labor, the Contractor and subcontractors shall pay not less than the higher wage rate. The Department will not accept lower State wage rates not specifically included in the Federal minimum wage determination. This includes "helper" (or other classifications based on hours of experience) or any other classification not appearing in the Federal wage determinations. Where Federal wage determinations do not contain the State wage rate determination otherwise available for use by the Contractor and subcontractors, the Contractor and subcontractors shall pay not less than the Federal minimum wage rate, which most closely approximates the duties of the employee in question.

No employee of the City of Colfax shall have any direct financial interest in this contract. This contract shall be voidable at the option of the City if this provision is violated.

The City of Colfax desires wherever possible, to hire qualified local residents to work on City projects. Local residents is defined as a person who resides in Placer County. The City encourages an active affirmative action program on the part of its contractors, consultants, and developers.

Engineer's Estimate of Probable Construction Cost (Base Bid plus Additive) is \$4,781,000

The Labor Surcharge and Equipment Rental Rates in effect on the date the work is accomplished will apply to work done under this contract.
