

Admin. Law Judge Sides With City In {Colfax v. CalPERS}

The May 13 Colfax City Council meeting opened with City Attorney, Mick Cabral, characterizing the recent Administrative Law Judgment (ALJ) in {Colfax v. CalPERS} as a "complete win for the City. She found every fact and every issue in favor of the City and Laurie," Cabral said.

At issue was the state's contention that Laurie VanGronigen, the City Finance Director, was not a consultant but actually a full-time employee, which would require her and the City to make retroactive contributions to the state retirement fund (CalPERS) dating back to 2015.

"She found every fact and every issue in favor of the City and Laurie," Cabral said.

The state's claim was based on an initial complaint made on September 19, 2017 by former City employee, Travis Berry.

After receiving additional information from the City in late 2017, CalPERS issued a preliminary determination on April 16, 2018 that it found VanGroningen to be a common law, full-time employee eligible for CalPERS membership on July 1, 2015. The City opposed that finding in May 2018, and then appealed the final decision of CalPERS in September that year.

The City Attorney said that before reaching its decision CalPERS never bothered to interview either VanGroningen, the target of the initial complaint, or Berry, the initial complainant.

"If the City had lost, it would have had to pay its share of CalPERS contributions retroactive to July 1, 2015, and Laurie would have had to pay her share retroactive to July 1, 2015," Cabral said.

"Both the City and Laurie would have had to continue making contributions going forward until Laurie was no longer working for the City. Overall, it would have significantly increased the City's cost of filling the position of Finance Director."

The appeal process included two days of live hearings in front of an independent Administrative Law Judge (ALJ) in November and December

Placer Supervisors Seek Permission For Phase 3 Reopening

Pointing to Placer County's success at flattening the CO-VID-19 curve and the proactive efforts of the local business community to prepare for safely reopening, the county Board of Supervisors unanimously approved a resolution to request permission from the state to move into Stage 3 of California's reopening roadmap.

The resolution asks for the state to allow reopening of Stage 3 businesses in Placer County such as nail salons, gyms, lodging for tourism and entertainment venues - with adaptations and limits on size of gatherings. It also requests that youth sports and programs be allowed to resume.

Acknowledging the significance of the summer season for Placer's tourism-based economy in eastern Placer County, the resolution asks for specific flexibility to reopen for tourism no later than June 1 and for the state to provide reopening guidance for the industry.

"Businesses just trying to keep employees to help pay their bills and put food on the table for their families," said District 5 Supervisor Cindy Gustafson. "I'm not supporting this because of economic gains or county revenues. This is about community members who are dramatically suffering. Some of our small business people are losing everything they've worked their whole lives for."

City Council Approves New Stop Signs For Forest Hill St.

The recently finished engineering study and review for additional traffic control on Forest Hill St. will result in some new signage, as well as changing the location of at least one stop sign and removal of another. The study and review were initiated by a request from council member Joe Fatula.

The study commenced with a search of accident record systems to determine any history of accidents in the study area. The two record systems that were searched – TIMS (Traffic Injury Mapping System) and SWITRS (Statewide Integrated Traffic Records System) revealed no reportable or injury accidents occurred in the area during the time frame of 2013-2018.


Potential evaluation and report preparation costs were minimized with a dual approach that used Google Earth street views, followed up by an actual field review to verify that conditions had not changed since the Google images were made.

The city engineer, Larry Wing, said the cost for the study and review was \$2,000.

Analysis of the study's findings produced the following recommendations:

- Intersections where traffic control should be installed:
- 1. Marvin Street and S. Forest Hill St.: install a westbound Stop sign on the Marvin St. approach to supplement the existing eastbound Stop control.
- 2. S. Forest Hill St. and E. Church St.: Due to visibility issues, install Yield signs on both the northbound and southbound S. Forest Hill approaches.
- 3. S. Forest Hill St. and Oak Street: Install Stop signs on both the northbound and southbound approaches to this intersection.

2019, before the judge issued her decision in the City's favor on March 23 this year.

Cabral noted that ALJ decisions are not binding; they are proposed, recommended decisions that are presented to the CalPERS Board for acceptance or rejection.

If the full CalPERS Board had rejected the decision, the City would have had to sue CalPERS in Sacramento County Superior Court. Cabral said that could have dragged on for at least three years and cost many tens of thousands of dollars.

Instead, CalPERS opted to settle. It agreed to vacate its erroneous final determination, deem VanGroningen an independent contractor and end its dispute with Colfax.

It should also be noted that, after dragging the City through the administrative legal process over what turned out to be an unwarranted complaint, CalP-ERS is not obligated to reim-

burse any of the City's legal fees and costs.

City Manager Wes Heathcock said the City's legal defense costs stood at \$43,195 before any additional costs to wrapup the settlement agreement, which he estimated would bring the total bill to around \$45,000.

- One location where the existing traffic control device required modifications:
- 1. Marvin Street and S. Forest Hill St. eastbound: The existing Stop sign is located on the wrong side of the approach; it needs to be relocated.
- One location where the traffic control device should be removed:
- 1. North Star Avenue and Marvin Street: Remove the northbound Stop sign. There is no other intersection control, since Marvin Street dead ends at this location and visibility is not an issue.
- Two (2) locations accessing SR-174 requires modification:
- 1. S. Forest Hill St. and SR174: Install a Stop sign on the southbound Forest Hill St. approach.
- 2. Vista and SR 174: The existing Stop sign is located in shadows and too far to the right of the approach. It needs relocation to improve motorists' visibility of the sign.

Unanimously approved by the city council, the intersection controls will not be placed until the CDBG Road Rehabilitation project is installed.

Colfax Memorial Day 2020 Celebration Muffled By COVID-19

Everyone attending the brief ceremony followed safety protocols as set out by the county health department.


