CAL FIRE: Burn Permits Will Be Required Starting May 1

As of May 1st 2021, Residential Door Yard Burn Permits will be required for all outside burning in the CAL FIRE Nevada/Yuba/Placer Unit which includes the City of Colfax.

Burn permits can be obtained for free at:

- The CAL FIRE public website at <https://burnpermit.fire.ca.gov/> or
- The CAL FIRE/ Placer County Fire Department Colfax Station 30 at 24020 Fowler Ave, Colfax.



1. You must have in your possession a valid Residential Door Yard Burn Permit.
2. You may only burn on permissive burn days and between the permissive hours.
3. You must call the number listed on the burn permit to insure it is a permissive burn day, just prior to burning.
4. You can only burn dry natural material found on your property.
5. You may

Residential door yard burning is a valuable tool for homeowners to use annually in maintaining their property and providing the necessary defensible space for their homes. It is not without risk, however.

In 2020, 17 of 47 vegetation fires in the Colfax/ Alta Battalion area were related to residential door yard burning. This spring alone with the dryer than normal weather, we have responded to over a dozen escaped control burns burning several acres in total.

Homeowners and residents must be aware that if their fire escapes their control, or if they are not following the rules of the Residential Door Yard Burning permit, they may be found liable for any damages that occur or suppression costs resulting from a Fire Department response.

Outlined below are the rules for safely conducting a door yard burn:

Council Debates Implementing A Technical Device Policy

The April 28 meeting of the Colfax City Council, which was held in person with a Zoom option for the stay-at-home audience, needed just 50 minutes to go from gavel to gavel.

CalFire Chief/Colfax, Alta Battalion Brian Eagan led things off with a warning that the permitted burn season could be cut short due to extreme dryness. He also cautioned citizens about their cleanup fires, saying that half of the escaped fires his crew have responded to so far this season were left burning and unattended when they got away.

From there the meeting moved quickly to Item 9A, the night's one piece of Council business.

Drought-Like Weather Continues



Honeybees pollinating the area's pear trees were never bothered by spring rain in April simply because less than an inch fell all month. The five-year average (2016–2020) for April rain is 5.2 inches, and the five-year average for total rainfall at the beginning of April is 52.7 inches. This year we started April with 23.05 inches and finished the month with exactly 24 inches.

Looking ahead to May, the five-year average for the month is barely 2.5 inches because two of those years received less than an inch in May, and one other year (2017) had no rain at all.

In 2020 we ended the wet season with 36.04 inches total. As we start this month we are 12.04 inches off last year's pace, and based on the five-year averages the odds are exceedingly long that we will finish the season anywhere near 30 inches, let alone 36.

The five-year average for June rainfall is .02 inches, so there's probably no help there either.

The item was prompted by recent requests from Council Members asking for the city to provide technology devices for their City business use. City staff brought the issue to the council in an open meeting asking for direction regarding the creation of a "technical device policy."

To shape the discussion the item offered five questions for the council to consider:

- Does the Council want to provide Council Members with any type of technology devices at City expense for use in conducting City business? If the answer is "No", the discussion can end here.
- If "yes", what type of technology devices does Council want to authorize the City to issue its members?
- How much funding for such devices is the Council willing to authorize, and from what funding source?
- Will this be a one-time authorization, an annual funding allocation, or an as-needed funding allocation?
- What guidelines and restrictions will be established on the use of the technology devices?
- How will the selection of devices be handled? For example, will each Council Member be able to choose his/her own device, or will each Council Member be limited to the same

type of device?

Before throwing the discussion to the council, City Manager Wes Heathcock said, "If the answer to the first question is 'No' then the discussion can stop there."

Council members Burruss, Mendoza and Ackerman initially came out against spending city money on IT devices for the council. Council member Fatula was in favor, saying it would allow council members to separate official use from personal use in the event that council devices were subpoenaed and searched.

Several suggestions were made to deal with that eventuality, including increasing the council monthly stipend to cover IT costs for new council devices, setting up a council workstation in city hall that would be available to all council members, and having the city purchase and manage IT devices for Council Members, which would be official city property.

The item closed when Mayor Lomen directed staff to investigate costs for those potential solutions, and bring the item back at a future meeting.

The next meeting of the Colfax City Council will held on Wednesday, May 26.

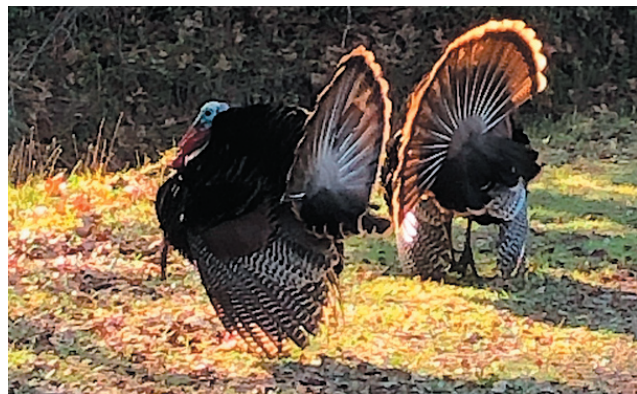

not burn any trash, lumber or household waste.

6. You can only burn in a pile no larger than 4 feet in diameter.

7. You must have 10 feet of clearance around the entire pile to bare dirt.

8. You must have in your possession water and a hand tool while you are burning.

9. You must be in attendance at all times while your pile is

still burning.

Based on weather and fuel conditions residents should expect that sometime between June 1st and July 1st 2021 all outside burning will be suspended.

After that date and until the suspension is lifted sometime in late fall 2021 no residential door yard burning can occur.

As an alternative to residential door yard burning, residents in Placer County, including the

City of Colfax, may take advantage of the Placer Resource Conservation District Chipper Program to dispose of their annual natural material.

Nevada County Planning To Replace One-Lane Dog Bar Bridge

Nevada County has replaced or rehabilitated seven bridges in western Nevada County since 2017. The County expects to replace four more bridges by 2022, including the Dog Bar Road Bridge over the Bear River near Colfax.

The Dog Bar Road Bridge carries two-way traffic on a one-lane bridge connecting Nevada and Placer Counties. The narrow, 13' 8" wide bridge was built in 1934 and does not meet modern standards for bridge cross sections.

Based on a feasibility study conducted in April 2020, the removal of the existing bridge and replacement with a new, broadened curve radius was found to be the best solution. The plan is to remove the existing bridge and replace it with a two-lane, cast-in-place, pre-stressed concrete U-shaped bridge, approximately 235 feet long, directly upstream from the current bridge site.

As designed the new bridge will be approximately 32' wide with two lanes each 11' wide, with a 135' curve radius that will accommodate larger trucks. Traffic will be relatively undisturbed on the existing bridge during construction, with the existing bridge being removed after traffic is moved onto the new bridge.

Friends of the Bear River has expressed a "resounding Yes!" in support of replacing the bridge.

It is tempered with the concern that the current plan does "not accommodate the area's growing recreational economy and rural lifestyle, and reduces existing recreational amenities to a commuter corridor that is unsafe for humans on foot, bike, horse or boat."

Specifically those concerns include:

- Safe parking off the road for river access
- Safe pedestrian and bicycle

crossing over the new bridge, or retaining the old bridge for pedestrian/bicycle/horse crossing

- Trailhead access on both sides of the river, with safe pedestrian access
- A safe loading zone at trailheads for beach and picnic gear, boating and mining gear
- A staging area for boater take-out
