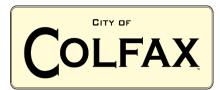

Andy Fecko, General Manager of PCWA, spoke about the Drum Spaulding infrastructure damage that PG&E is having at the Powerhouse that will significantly affect water deliveries to Nevada County and Western Placer County through at least June 15, 2024.

Monica Reyes, Director of Recreation for NID, reports that with the infrastructure damage, there is only natural runoff water that will be feeding Rollins Lake until that damage is repaired, and what potential impacts that could mean for recreation at Rollins like this summer.

Diane Green reminded everyone of the food distribution at Sierra Vista Community Center at 55 School St. on April 2, 2024. It was noted that food distribution will be the first Tuesday of every month.

Tim Ryan asked about fire protection in regard to the water issue spoken about previously.

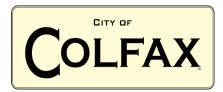

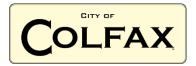
Conclusions and Findings

Relocation AD Hoc Committee Assignment

Summary/Background

The Caboose in Colfax holds significant historical value as a piece of railroad equipment. Originally serving on the Northwestern Pacific line, a Southern Pacific subsidiary, it is an exact replica of the prototype Southern Pacific caboose commonly used on the Donner Pass Route through Colfax. This makes it a valuable resource for promoting the railroad history of both the transcontinental rail line and the local community.

The Caboose is currently located at the Corner of Grass Valley and Main Street, and the Placer Sierra Railroad Heritage Society (PSRHS) would like to move it to the Depot area. The society's long-term vision involves creating an outdoor railroad museum for the community to enjoy. This museum will provide educational opportunities for visitors of all ages, helping them to understand the significance of the caboose in railroad history and operations not only in California but also across the nation.

Conclusions and Findings

The Placer Sierra Railroad Heritage Society will initiate fundraising efforts to cover the relocation costs of the caboose. Due to its size, there are limited suitable areas within the Depot vicinity for its placement. Therefore, the formation of an Ad Hoc committee is necessary to collaborate with the PSRHS. Their task will involve making a final recommendation to the city council regarding the new location of the caboose.
